### EXPLANATION:

This emergency order closes the resident and nonresident goat hunting seasons in the Takshanuk Mountain Range portion of hunt area RG023 in the area north and east of the Haines Highway and Chilkat River, west of the Chilkoot River and Lake, and north to Goat Hollow. This order takes effect at 11:59 pm, Friday, October 14, 2011.

### REGULATORY TEXT:

Therefore, the provisions of 5 AAC 85.040, HUNTING SEASONS AND BAG LIMITS FOR GOAT, are superseded by this emergency order, and the following provisions are effective for hunting goat in Unit 1(D):

Unit and Bag Limit	Resident Open Season (Subsistence and General Hunts)	Nonresident Open Season
(1) ...		
Unit 1(D), that portion east of the Haines Highway and Chilkat River, and west of the Chilkoot River and Lake, and north to Goat Hollow:	Sept. 15–Oct. 30 (General hunt only)	Sept. 15–Oct. 30

1 goat by registration permit only.

The remainder of Unit 1D mountain goat seasons, other than those previously closed by emergency order, are not affected by this emergency order.

JUSTIFICATION:

Biologists have set a guideline harvest objective of 10 points (male goats=1 point & female goats=2 points) for this area. As of Thursday afternoon, October 13, 2011, 6 billies (6 points) and 2 nannies (4 points) have been harvested for a total of 10 points. Because the guideline harvest level has been met an emergency order (01-16-11) is being issued to close the mountain goat hunting season in the Takshanuk Mountain portion of Unit 1D at 11:59 pm, Friday, October 14, 2011.
