EXPLANATION:

This emergency order closes the resident and nonresident goat hunting seasons in the Lutak Inlet-Chilkoot Lake portion of hunt area RG023 between Taiyasanka Harbor and the northern end of Chilkoot Lake. This order takes effect at **11:59 pm, Wednesday, November 8, 2017**

REGULATORY TEXT:

Therefore, the provisions of 5 AAC 85.040, HUNTING SEASONS AND BAG LIMITS FOR GOAT, are superseded by this emergency order, and the following provisions are effective for hunting goat in Unit 1(D):

Unit 1(D), that portion east of Lutak Inlet and Chilkoot Lake between Taiyasanka Harbor and the 4300 foot saddle east of the northern end of Chilkoot Lake	Sept. 15–Nov. 8 (General hunt only)	Sept. 15–Nov. 8

1 goat by registration permit only.

The remainder of Unit 1D mountain goat seasons, other than those previously closed by emergency order, are not affected by this emergency order.

JUSTIFICATION:

The guideline harvest level for mountain goat has been met along Chilkoot Lake and Lutak Inlet, from Taiyasanka harbor to the northern end of Chilkoot Lake. This emergency order (01-18-17) is being issued to close the goat hunting season in this area at 11:59 pm on Wednesday, November 8, 2017.

Based on a fall 2016 aerial survey (27 adults, 7 kids) a guideline harvest objective of 1-2 points (male goat=1 point & female goat=2 points) was established for the area described above. As of Tuesday November 7, 2017, two male goats have been harvested in this area, for a total of 2 points. Due to the vulnerability of goats in this area, low number of goats observed during aerial surveys, and because the guideline harvest level has been met, this emergency order (01-18-17) is being issued.
