
Spot Shrimp Selected Life History Traits

- Life span of seven to ten years
- Sedentary
 - Susceptible to localized depletion
- Protandrous hermaphrodites
 - Begin life as males



• Become female later in life at larger size (~35 mm carapace length)

PWS Historical Commercial Pot Shrimp Fishery




PWS Commercial Pot Shrimp Fishery Management Components 1960-1992

- 1960-1981
 - Open year-round
 - No harvest restrictions
- 1982
 - April 1 November 30 open season
 - GHR 75,000 to 145,000 lb
- 1984
 - March 15 to June 30 and August 15 to December 15 open seasons
 - GHR 75,000 to 100,000 lb for each season
 - Montague Strait experimental harvest area established

PWS Commercial Pot Shrimp Fishery Management Components (cont.) 1960-1992

- 1988
 - Montague Strait experimental harvest area closed
 - Southwestern portion of traditional harvest area closed
- 1990
 - Montague Strait experimental harvest area abolished
 - March 15 to May 1 and August 15 to December 15 open seasons
 - Gear limit of 150 pots
 - 7/8-inch rigid mesh required on each shrimp pot
- 1992
 - Fishery closed



PWS Commercial Shrimp Pot Fishery

Closed 1992-2009

Possible Reasons for the Decline of PWS Spot Shrimp

- Overfishing
 - Year-round fishing
 - Incomplete and late catch reporting
- Unfavorable environmental conditions

PWS Noncommercial Pot Shrimp

• Prior to 2001

- Open year-round
- Gear limits (Sport, PU) 5 pots/person, 10/vessel
- Gear limits (Subsistence) 10 pots/person, 20/vessel
- Low harvest (2,950 lbs avg. SWHS Sport Harvest)

• 2001 to 2008

- Season established: April 15 Sept 15
- Gear restrictions 5 pot/person, max 5 per vessel
- A harvest permit required
- Increasing effort and harvest


PWS Noncommercial Pot Shrimp

2009 to Present

- PWS Noncommercial Shrimp Fishery Management Plan
 - Relies on estimates of total allowable harvest (TAH)
 - 60% of TAH allocated to the non-commercial users
 - Harvest permit required for all users
 - EO authority to increase or decrease number of pots, time, or area

Number of Noncommercial Shrimp Permits Issued





Estimates of Shrimp Harvest in Noncommercial Fisheries by Permit (2002-2005, 2009-2011) and Allocation (2009-2012)



PWS Commercial Pot Shrimp Fishery Current Management Components

- 1) Harvestable surplus must be at least 110,000 lb for a commercial fishery to open
- 2) Allocation is 40% of total allowable harvest
- 3) Fishery rotates among three areas

PWS Commercial Pot Shrimp Fishery



PWS Commercial Pot Shrimp Fishery Current Management Components (continued)

- 4) Fishery-dependent gear limits
- 5) Hours of gear operation
 - 8:00 a.m. to 4:00 p.m., unless modified by emergency order
- 6) Reporting requirements
 - Wednesday call-in report
 - Prior to landing call-in report
 - Written logbooks

2010 PWS Commercial Pot Shrimp Fishery

- 55,000 lb GHL
- 155 vessels registered
 - 73 vessels (82 individuals) participated
 - 12 vessels >2 trips
- 45,349 lb harvested
 - Fishery CPUE 2.5 lb/pot
 - Estimated exvessel value of \$193,000

2010 PWS Commercial Pot Shrimp Fishery Management Elements

- 20-pot limit
- Began with short fishing periods
- Hours of gear operation were extended
- Effort declined steadily
- Closed by regulation September 15

2011 PWS Commercial Pot Shrimp Fishery

- 52,760 lb guideline harvest level
- 91 vessels registered
 - 44 vessels (48 individuals) participated
 - 16 vessels >2 trips
- 52,694 lb harvested
 - Fishery CPUE 1.78 lb/pot
 - Exvessel value of \$240,000


2011 PWS Commercial Pot Shrimp Fishery Management Elements


- 40-pot limit
- Began with short fishing periods
- Hours of gear operation were extended twice
- Effort declined steadily
- Closed by emergency order on July 29


2012 PWS Commercial Pot Shrimp Fishery Outlook

- 51,240 lb GHL
- Fishery will occur in Area 3
- Pot limits will be set following April 1 registration deadline
- Fishery will likely open with short fishing periods
- Hours of gear operation will be adjusted as necessary


PWS ADF&G Spot Shrimp Survey Locations
