Alaska Pacific Cod Fisheries


Federal: Federal waters (3-200 nmi) guided by NPFMC

process. Harvest deducted from federal TAC.


Parallel: State waters (0-3) nmi concurrent with adjacent federal fishery and generally adopt federal regulations and management measures as guided by the board process. Harvest deducted from federal TAC.

State-waters (GHL): State waters (0-3 nmi) guided by the board process. Harvest deducted from state GHL.

- Fishery began 2006
- GHL = 27% federal AI ABC
 - Increases 4% each year following achievement of GHL to a max 39%
 - 15 million lb GHL limit
 - Not allocated between gear types
- Open Access Non-exclusive registration area
- Two seasons:
 - Jan 1 ≤ 60 ft OAL Adak Section
 - Mid-March larger vessels
- Legal gear
 - Pots, trawl, jig, longline, hand trawl
- 150,000 lb daily and trip limit

- Jan 1 opening Adak Section
 - ≤ 60 ft trawl, pot, jig
 - ≤ 58 ft longline
- Mid-March opening, based on federal trawl closure
 - ≤ 125 ft pot
 - ≤ 100 ft trawl
 - ≤ 58 ft jig, longline
- 150,000 lb daily and delivery limit
- Non-exclusive registration area

Proposed

- Open 7 days after federal BSAI under 60 pot and HAL closure
- Pot vessels ≤ 58 ft OAL
 - 60 pot limit
- No harvest limitations
- Exclusive registration area




Eliminate the 15 million lb AIS GHL limit

- Fishery historically underutilized
 - GHL achieved in 2007, 2008, and 2018
- GHL limit established in 2015
- Reduce likelihood of foregone harvest
 - No shore-based processor
 - Limited participation



Adjust the annual AIS GHL based on western Aleutian processor availability

- For years without a shore-based processor
 - Lowers baseline GHL from 27% to 13.5% of AI ABC
- When processor is operational in communities of Adak or Atka
 - GHL set according to current regulations
- Fishery historically underutilized
- Reduce likelihood of unharvested GHL
 - No shore-based processor
 - Limited participation



Reduce the annual AIS GHL based on the harvest in the preceding year

Currently:

- ≥ 90% harvest = GHL achieved
 - GHL step up
- Baseline GHL = 27% federal AI ABC
 - Increases 4% each year following achievement of GHL to a max 39%
- Reduction inline with step up regulations
- < 85% harvest of GHL
 - GHL not achieved
 - GHL reduced step-wise by 4% from previous year to a minimum of 11% of AI ABC
- Reduce likelihood of unharvested GHL
 - No shore-based processor
 - Limited participation



Increase the 2020 AIS GHL based on the federal set-aside that is not available in the Aleutian Islands due to unrestricted trawl harvest in the 2019 fishery

- Federal set-aside not recognized in state regulations
- Adopted in 2016 and first enacted in 2018
- May increase GHL by as much as 11 million lb (5,000 mt)
- Not accrue toward 15 million lb limit
- May pre-empt federal fishery

Prior to October 31, 2017, NMFS received timely notice from the City of Adak indicating intent to process Al Pacific cod for the 2018 season. Accordingly, the harvest limits in Table 9a will be in effect in 2018, subject to the performance requirements outlined in § 679.20(a)(7)(viii).


Establish a 60 ft OAL size limit on all vessels in AIS

 - ≤ 58 ft jig, longline
- 150,000 lb daily and delivery limit



- ≤ 58 ft longline
- 150,000 lb daily and delivery limit
- Roll over provision



Allow trawl vessels 100 ft or less OAL with holding capacity of ≤ 250,000 lb to fish in the Adak Section during state-waters and parallel seasons



Bering Sea – Aleutian Islands Area Parallel Pacific cod Fisheries

- Occur when there are no state waters fishery open for a vessel's gear type and size
- Inside state-waters; corresponds with the times, area, and gear of the federal season in adjacent federal waters
- Mirrors federal regulations and Stellar sea lion protection measures except:
 - State waters between 175° and 178° W. Long
 - Vessel size limits:
 - Trawl, pot, jig, and hand troll gear no more than 60 feet OAL
 - Longline gear no more than 58 feet OAL
 - Kanaga Island/Ship Rock only a 3nmi sea lion closure (federal 10 nmi closure)

Kanaga Island/Ship Rock SSL Closure







Proportion of Harvest by Pots Registered








Proposal Intent: Close state waters in the DHS to trawl vessels during the state-waters season

As written:

- Close all state waters of the Bering Sea
 District
- Only small portion of the DHS
- Parallel P cod fishery open in DHS during state-waters season
 - Only closed to
 P cod pot vessels
 ≤60 ft OAL



Extend eastern boundary of DHS from 164 $^{\circ}$ W long to 162 $^{\circ}$ 30′ W long



Create state-waters P cod management plan for jig vessels in DHS


Current

- GHL= 6.4% federal BS ABC
- Pot gear vessels ≤58 ft OAL
- Exclusive registration area
- All state waters of DHS
- Parallel jig fishery open concurrent to DHS state-waters fishery
- Bogoslof Exemption Area allocated 113 mt for HAL and jig C/V ≤ 60 ft OAL in federal regulation
 - C/Ps are allowed in state-waters

Proposed

- Create 100,000 lb GHL
- Jig gear vessels only
- Non-exclusive registration area
- State-waters from 167° 170° W long
- Management considerations







Create a 150,000 lb daily harvest and delivery limit on vessels participating in the DHS Pacific cod fishery and require daily reporting


- Legal gear

- No trip limitations
- Reporting requirements currently established by in-season managers






Coordinate season opening dates between Chignik Area statewaters and parallel Pacific cod fisheries

- Roll-over allocation from jig to pot gear
- Roll-over moved from Oct 30 to Aug 15
- Parallel open Sept 1
- Only allows for 2 week harvest



Repeal weather delay provision for jig vessels during the South Alaska Peninsula Pacific cod fishery

- Jig allocation not achieved since 2014
- Recent seasons open mid-March through December
- Ave weather delay is 3 days
