



Miscellaneous Business Agenda (RC44):

- 1. Bristol Bay Advisory Panel update and board generated proposal: Member Johnson provided an update and overview on the Bristol Bay Advisory Panel, a group established at the 2012 Bristol Bay finfish meeting to review options related to establishing an optimum escapement goal, prior to setting such a goal. Member Johnson moved to adopt a board generated proposal (RC25) to establish an optimum escapement goal for Bristol Bay sockeye. The proposal was adopted by the board on a 7 to 0 vote. The board generated proposal, now Proposal 277, is scheduled for the Statewide Dungeness, Shrimp, Miscellaneous Shellfish and Other Issues, set for March 17-20, 2015 in Anchorage. - 2. Kuskokwim Subsistence Salmon Panel update and board generated proposal: Panel chair Kluberton provided an update on the Panel's recent meeting in Bethel on January 15-16 and provided reports of the meeting through RC's 32 and 33. Member Kluberton moved to adopt a board generated proposal (RC34) to create a provision allowing live boxes on Kuskokwim fish wheels to allow the return of king salmon during times of king salmon conservation. The proposal was adopted by the board on a 7 to 0 vote. The board generated proposal, now Proposal 278, is set for the Statewide Dungeness, Shrimp, Miscellaneous Shellfish and Other Issues, scheduled for March 17-20, 2015 in Anchorage. - 3. Shrimp Task Force Charge and Pot Shrimp Management Plan: The board discussed the ongoing work of the shrimp task force and a request for the board to create a finding supporting the task force. While identifying the task force work with the department as impressive and exemplary, it did not find the effort met the requirements of a board finding as identified in the Policy on Development of Findings (99-184-FB). - 4. Combining Southeast finfish and crab meetings in the future: The board discussed the potential for combining the currently separate Southeast finfish and shellfish meetings. It was determined
