Dillingham Area - Unit 17

- <u>CA</u> 45 Change the hunting regulations for the Mulchatna Caribou Herd in Units 9, 17, 18 and 19. Amended with substitute language, RC 78, to clean up regulatory language describing current boundaries.
- F 46 Modify the caribou hunting season dates in Unit 17.
- <u>F</u> 47 Open a nonresident caribou season in Unit 17B with certain conditions.
- <u>CA</u> 48 Establish a nonresident registration hunt in Togiak National Wildlife Refuge in Unit 17A. Amended with substitute language, RC 79, to open a registration hunt, season Sept. 5-15, up to 20 permits to be issued the first year.
- F 49 Decrease the bag limit for brown bear in Unit 17B.
- F 50 Allow the sale of brown bear in Unit 17.
- <u>C</u> 51 Change hunting regulations for black bear in Unit 17 to a bag limit of three bears per year and no closed season.

Miscellaneous Actions

The board considered an petition (RC 10) on February 8 submitted by Al Barrette, requesting review of 5 AAC 92.095, Unlawful methods of taking furbearers; exceptions. Specifically, the petition requested clarification for the term "taken" by replacing it with "incidentally taken". The board did not find that the petition justified an emergency regulation. Instead, the board requested a board generated proposal on the issue be scheduled for the March 2013, Southcentral Region meeting.

The board held an executive session on Monday, February 11 for the purpose of receiving an update on pending litigation concerning Nelchina caribou and subsistence hunting regulations.

The board requested a board generated proposal to clarify salvage regulations for brown bear meat taken at bait stations, be scheduled for the 2014 Interior/Northeast Region meeting.

The board adopted findings (RC 118) giving direction to ADF&G provided during the Central/Southwest Region meeting.

The meeting adjourned on February 14, 2013 at approximately 6:12 p.m.
