


Moose Harvest – Lower Yukon Area



Winter Harvest – Lower Yukon Area





History of Muskox – Nelson Island

- ➤ 1850–1860 Muskox were extirpated from Alaska.
- 1930 34 Musk ox were captured in Greenland.
- ➤ 1930–1936 Muskox were retained and reared in Fairbanks.
- > 1935–1936 31 Muskox were released on Nunivak Island.
- 1967–1968 23 Muskox were transplanted from Nunivak Island to Nelson Island.
- First hunting on Nunivak Island.
- First observation of a muskox on mainland.
- > 1981 First hunting on Nelson Island.
- 2013 Currently, 150-200 muskox on mainland.

Nelson Island Muskox Management Plan

- Nelson Island Muskox Herd Cooperative Management Plan
- Drafted in January 1995
- Cooperators: Villages, ADF&G, USFWS, Subsistence users
- Purpose: joint commitment to manage for a sustained yield of muskox that both benefits the muskox population and the users of the muskoxen on Nelson Island
- Harvest management: no harvest when pre-calving count is less than 250 muskox; 10% and higher harvest when precalving count is higher than 250 muskox.
- Habitat management: protect and maintain the habitat and other components of the ecosystem upon which the herd depends.

Department Management Objectives

- Maintain a post-hunt pre-calving population of at least 250 muskoxen on Nelson Island, and 500–550 on Nunivak Island.
- Issue drawing and registration permits for harvesting muskoxen to maintain optimal size, composition, and productivity of the muskox populations on Nunivak and Nelson Islands.
- Provide hunter orientation and post-hunt checkout to ensure hunters understand permit requirements, properly identify legal muskoxen, and report their harvests in a timely and accurate manner.
- Determine the distribution and dispersal of muskoxen on the mainland.
- Use the cooperative management plans for Nunivak and Nelson Islands.






Nelson Island Muskox Population

- Emigration to mainland
- Accidental death (lost on sea-ice)
- Hunting harvest (no natural predators)

Recent high population has resulted from:

- Cessation of emigration to mainland
- Less accidental death
- Limit on number of permits for hunting

Continued high population risks reducing range quality

Removing the 'up to' limit on permits allows flexibility to issue the number of permits needed to maintain population at management objectives.


Current 'Published' Map


Map of Current Codified Regulations




Boundary Comparisons






All Boundary Options

5 AAC 92.085 – Unlawful Methods

Current Regulation

The following methods and means of taking big game are prohibited in addition to the prohibitions in 5 AAC 92.080:
(1) with the use of a firearm other than a shotgun, muzzleloader, or rifle or pistol using a center-firing cartridge, except that ...

<u>Proposed Regulation</u> The intent of the regulation is:

(1) with the use of a firearm other than a shotgun, muzzleloader, or rifle or pistol using a center-firing cartridge, except that *in Unit 18, big game not including wolf and wolverine may only be taken with calibers larger than 22 caliber* ...

Background

Firearm and caliber restrictions may be:

- Method-based (e g. muzzleloader)
- Unit-based (e g. Unit 18 nontoxic shot for taking game)
- Statewide (e.g. center-firing cartridges for taking big game)

Reducing wounding loss is a major consideration for restrictions

Small calibers....

- Leave little room for error with shot placement
- If used correctly, can be effective at taking big game
- Commercial ammunition may not be appropriate
- Rifles are popular and easily accessible to hunters
- May allow more youth hunt opportunities

Proposal 12: Unit 18 Wildfowl

This proposal changes the salvage requirement for wildfowl in Unit 18 to include all edible portions of migratory and upland birds, except the wingtip, feathers and non-edible entrails.

Current Regulations

5 AAC 92.220. Salvage of game meat, furs, and hides

•••

(d) A person taking game not listed in (a) of this section shall salvage for human consumption all edible meat, as defined in 5 AAC 92.990. In addition, ...

5 AAC 92.990. Definitions

...

(17) "edible meat" means, ... in the case of wild fowl, the meat of the breast; however, "edible meat" of big game or wild fowl does not include meat of the head, meat that has been damaged and made inedible by the method of taking, bones, sinew, incidental meat reasonably lost as a result of boning or a close trimming of the bones, or viscera;

Proposed Regulation

Proposal 12: Require salvage of all meat of the skeleton.

Lower Kuskokwim AC Amendment: same as Statewide Proposal 152

Proposal 152:

(17) "edible meat" means, in the case of *wildfowl* or a big game animal, except a black bear, the meat of the ribs, neck, brisket, front quarters as far as the distal joint of the radius-ulna (knee), hindquarters as far as the distal joint of the tibia-fibula (hock), and the meat along the backbone between the front and hindquarters; in the case of a black bear, the meat of the front quarters and hindquarters and meat along the backbone (backstrap); [IN THE CASE OF WILD FOWL, THE MEAT OF THE BREAST;] however, "edible meat" of big game or wild fowl does not include meat of the head, meat that has been damaged and made inedible by the method of taking, bones, sinew, incidental meat reasonably lost as a result of boning or a close trimming of the bones, or viscera;

Background

- Salvage regulations normally considered at statewide meetings
- Response to local event in Unit 18 where only the 'meat of the breast' was salvaged from a number of swans
- Strong community reaction about unacceptable waste.
- This proposal attempts to make salvage requirements consistent with regional cultural and traditional practices in Unit 18.
- Current regulations define the *minimum* statewide standards
- Hunters may salvage additional parts of the birds they harvest.
- Proposal 152, suggested as an AC amendment is scheduled for the Statewide Meeting, March 2014
