

Copper Basin Hunt History Highlights

Caribou

- Most hunting under TierII from 1991-2008
- ANS was 100% surplus
- Registration hunt in 1996 and 1997 to reduce herd to objectives
 - 50,000 permits
 - 20,000 hunters

Moose

- Tier II from 1995-2008
- General season with antler restrictions

Both Species: Federal seasons

Current Hunt Structure

Developed between 2006 and 2013

Current Opportunities

Caribou

- Tier I Registration
- Community Subsistence Harvest (CSH)
- Draw

Moose

- General (SF/50"/4 brow tines)
- Community Subsistence Harvest
 - SF/50"/4 Brow tines on at least one side
 - 100 "any bulls"
- Resident Draw ("any bull"; 5 permits)
- Resident Draw (antlerless; 10 permits)
- Non-resident Draw (50"/ 4 brow tines; 115 permits)

Copper Basin CSH Hunt

- CSH hunt area (5AAC 92.072 & 5AAC 92.074)
- Custom of community-based harvest and sharing
- Other characteristics of C&T practices in the hunt area
- Community or group coordinator (CSH permittee)
- 25 or more members
- Two-year commitment
- Salvage requirements

Copper Basin CSH Hunt

- Copper Basin caribou: 1 per household
 - May not hold any other state caribou harvest ticket or permit
 - May not hunt moose outside of the Copper Basin CSH hunt area
- Copper Basin moose: 1 SF/50/4 BT per person & up to 100 "any bulls"
 - 1 "any bull" per every 3 households
 - May not apply for any state moose or caribou permits outside of the CSH hunt area
 - May not hold general season harvest tickets
- Season opens Sept. 20, designated hunter, no trophy destruction





Emergency Order Extension of fall season September 30

Nelchina Caribou Herd Management Outlook

- Above population objective (35,000-40,000)
- 49,950 caribou (July 2016)
- Increased permit numbers (14,475 in 2016)
- 2016 harvest highest since 1996
- Harvest quotas and permits issued will continue to be adjusted based on the best available data

Nelchina Caribou Herd

2016 Management Actions

2016 Harvest Quota

- > Harvest quota was originally set at 4,000 caribou based on a preliminary estimate of herd size (2,000 bulls & 2,000 cows)
- Quota removed because final estimate was well above objectives

Emergency Order

> Extended fall hunting season to Sept. 30

Federal Subsistence Winter Season

Opened 6 days early (Oct. 15)

Nelchina Caribou Herd 2017 Emergency Regulations

- Substantial numbers of Nelchina caribou wintered within Unit 13 and were available for harvest
- ➤ BOG approved emergency regulations to increase the bag limit for Tier I (RC566) and CSH (CC001) from one to two caribou per household
- > The BOG also adopted a registration hunt option



CSH hunters can continue hunting SF/50/4BT bulls after Emergency Order

Unit 13 Moose Management Outlook

- Near or above population objectives in most subunits
- Above bull objectives (25:100) in all subunits but 13A (20:100)
- Combined annual harvest >1,000 bulls last 2 years
- Harvest quotas and permits issued will continue to be adjusted based on the best available data

RY2016 Hunt Summary

CARIBOU

- Harvest has exceeded 5,000 the most since 1996
- Fall season was extended from September 20 to September 30 to maximize harvest.
- Emergency regulation change to double bag limit

MOOSE

CSH:

Any-bull opportunity until the end of moose season

Harvest Ticket:

SF/50/4BT until throughout the season

- Complaints of "not enough moose"
 - Harvest has increased since 2013
- Some hunters point to CSH hunt as the problem
- Common Complaint Too many hunters
