### COOK INLET

**Experimental Fisheries** 

PROPOSAL NO. 133

#### **ACTION: Failed**

**DESCRIPTION:** Implement experimental fisheries using different fishing methods and means for salmon, herring and groundfish in Cook Inlet.

**DISCUSSION:** A commissioner's permit is available for experimental fisheries. Board is opposed to transferring its responsibilities to an additional governing body.

PROPOSAL NO. 134

#### ACTION: Carried as amended

**DESCRIPTION:** Create a new commercial smelt fishery in Northern Cook Inlet with dip nets as legal gear.

**AMENDMENT:** Intent to reauthorize the 1998 commercial smelt fishery regulation using dipnets with a 100-ton harvest cap.

**DISCUSSION:** Hooligan and smelt stocks are abundant throughout Upper Cook Inlet. The department can use its emergency order to close, if necessary. This fishery may provide some additional economic opportunity.

**AMENDMENT:** Add herring fishing in the Kalgin Island Subdistrict with a guideline harvest range of 0 to 20 tons.

**DISCUSSION:** These are traditional fishing area levels that are sustainable.

**DESCRIPTION:** Increase the allowable fishing time in the Upper Subdistrict. **AMENDMENT:** The gill net mesh size is less than 2.0 inches or greater than 2.5 inches **DISCUSSION:** This was conducted as a sac roe fishery, but is primarily used as a bait fishery. Board intent is to include this size in language for proposal 138.

#### Kasilof River Salmon Management Plan

#### **PROPOSAL NO. 140**

**DESCRIPTION:** Revise the BEG and OEG in the Kasilof River/Tustumena Lake. **DISCUSSION:** Supplemental production of sockeye salmon is ending as a result of court order. No action based on action taken on proposal 144.

#### PROPOSAL NO. 141

**DESCRIPTION:** Manage the Kasilof River for MSY and established goals. **DISCUSSION:** No action based on action taken on proposal 144.

#### Kenai River Late-Run King Salmon Management Plan

PROPOSAL NO. 142

**DESCRIPTION:** Between July 20 and 31, allow commercial harvest of sockeye if inriver projections are more than 600,000 and king salmon escapement goals are met. **DISCUSSION:** This is a housekeeping measure.

**AMENDMENTS:** Eliminated the windows priority over the inriver goal; continue abundance based management in the set gillnet fishery until harvest from two consecutive fishing periods is equal or less than 1 percent of the cumulative total sockeye harvest to date (applies Aug 1-10); In the Kasilof River provide for a season opener when sonar count is less than 50,000 from the mouth of the Kasilof River north to the Blanchard line and south of the mouth of the Kasilof River prior to June 20 (to June 25 – excluding Russian River). It is the intent of the board that while in most circumstances the department will adhere to the management plans in this chapter, nothing in the management plans is intended to override the commissioner's emergency order authority should significant new information arise inseason that, in the commissioner's judgment, warrants departure from the provisions in the management plans. Kenai River Coho Salmon Management Plan: Delete department requirement to manage the Upper Cook Inlet commercial salmon fisheries to minimize the incidental take of Kenai River coho salmon stocks: coho salmon fishing is prohibited from Nov 1 to June 30; any coho must be released without harm, from July 31 to end of king season through October 31, sport fishing from a vessel registered as a guide vessel is restricted; remove the prohibition of taking coho salmon and allows only unbaited, artificial lures to be used from the Kenai River downstream from Skilak Lake to the Soldotna Bridge. Remove the prohibition of additional drift gillnet fishing periods outside the Kasilof and Kenai sections of the Upper Subdistrict until significant harvestable surpluses of chum are available. Include a 12-hour emergency opening in the "south box." The closure in statistical area 245-70 is intended to go to August 10.

**DISCUSSION:** Board believes this proposal, as amended will address the mid to upper range of the sockeye abundance and provide the department with clear direction for management. Board discussed potential management problems due to overescapement. Board recognizes that its role is not intended to assist with the inseason management of the fishery. Multiple species and the multiple user groups of Cook Inlet have been taken into consideration in the development of this plan, with many of the stakeholders working together to offer the amended language.

**DISCUSSION:** The board cannot discriminate between the harvest of resident and nonresident commercial fishermen. The board is limited in its regulatory authority of the harvest by nonresident and resident sport fishing anglers in that the board can regulate harvest between nonresident and resident anglers that do not sell their fish.

#### PROPOSAL NO. 150

**DESCRIPTION:** Direct the department to manage within established BEG goal range. **DISCUSSION:** No action based on action taken on proposal 144.

#### PROPOSAL NO. 151

**DESCRIPTION:** Manage the fisheries based on BEGs rather than OEGs. **DISCUSSION:** No action based on action taken on proposal 144.

#### PROPOSAL NO. 152

**DESCRIPTION:** Remove reference to opening set gillnet fishery before drift gillnet fishery for product quality.

**DISCUSSION:** Current regulations cause an unnecessary burden on the drift fleet. This provision will allow management of the drift and set netters independently, to allow a spread of the harvest to accommodate processors and fishermen. Not all fishermen use the same processors. The board also discussed overwhelming the cannery capacities in a one-day period, and what would happen to the set net fishery the following day.

**AMENDMENTS**: In the Central District drift gillnet fishery, in Chinitna Bay, the season opens and closes by emergency order. Statistical areas described by 245-50, 245-55, 245-90 will be open to drift gillnetting during regular periods August 1 through August 10. The provision sunsets Dec. 31, 2007 Remove references to chum and pink salmon in the Northern District Salmon Management Plan. South of 60.42.30 latitude 151.42.30 longitude (a point on the southeast West Foreland) and seaward to one mile from mean low water, the season opens August 11 and is closed by emergency order.

**DISCUSSION**: There are big fly-out sport fish operations in the westside streams of Cook Inlet. There are coho salmon available all the way through August. Department can use emergency order authority for closures, as needed.

#### Seasons, Weekly fishing periods, Boundaries

#### PROPOSAL NO. 173

#### **ACTION: Failed**

**DESCRIPTION:** Redefine Kasilof boundary to reduce bycatch headed toward the Kenai River. **DISCUSSION:** This would disrupt current fishing patterns with no biological justification.

PROPOSAL NO. 174

**DESCRIPTION:** Clarify language for closed waters around the terminus of Big River.

**DISCUSSION:** At certain tide zones, it is possible this would create open areas that would vary. It is primarily used by setnetters and has been in effect since 1924. It would be difficult for enforcement to determine a boundary based on mean high tide.

#### PROPOSAL NO. 175

**DESCRIPTION:** Repeal window/mandatory corridor restriction for drift fleet in Northern District. **DISCUSSION:** No action based on action taken on proposal 144.

#### PROPOSAL NO. 176

**DESCRIPTION:** Close fishery by EO to prevent overescapement and waste. **DISCUSSION:** No action based on action taken on proposal 144.

#### PROPOSAL NO. 177

**DESCRIPTION:** Change scheduled days for regular periods for the Central District. **DISCUSSION:** No action based on action taken on proposal 144.

**DESCRIPTION:** Remove the regular period restrictions for drift fleet in the Northern District. **DISCUSSION:** No action based on action taken on proposal 144.

**DESCRIPTION:** Close all waters of Cook Inlet north of the Kenai River to all commercial fishing. **DISCUSSION:** A closure such as this would cause problems in the remainder of the Cook Inlet fisheries, and the closure is not justifiable.

**DESCRIPTION:** Establish inriver OEG in Northern Cook Inlet to include Knik Arm, Turnagain Arm, and Susitna drainage.

**DISCUSSION:** No action based on action taken on proposal 144.

**DESCRIPTION:** Allow commercial fishing to continue on Mondays and Thursdays until closed by EO.

#### **DESCRIPTION:** Increase Northern District Chinook fishing time.

**DISCUSSION:** A small opportunity to harvest some of the under-utilized kings would be provided. The area currently opens on May 25 and there are markets for early fish with prices generally higher at that time. Although the fishery could be closed by emergency order if it is anticipated that it would exceed the cap, there was a conservation concern expressed of the inriver Deshka users impact. Board prefers to find out the impact of previous additional fishing time allowed by proposal 184.

**DESCRIPTION:** Allow three 12-hour periods per week in the Central District. **DISCUSSION:** No action based on action taken on proposal 144.

#### PROPOSAL NO. 190

**DESCRIPTION:** Open the Central District on June 25 and close Sept. 1; allow three 12-hour periods per week; reinstate salmon spotting; increase drift gear to 200 fathoms; and allow monofilament web.

**DISCUSSION:** The concept of an "A-B fleet" is too complicated for Cook Inlet, and dual permit holders have many complexities.

#### PROPOSAL NO. 207

#### Gear, Registration, and Reporting

PROPOSAL NO. 212

**DESCRIPTION:** Delete gear restrictions in the Northern District.

**DISCUSSION:** This proposal addresses the August 1 – 10 fishing period. The provision was originally put in place due to a concern of coho conservation. Data shows a limited harvest of coho during this time.

#### PROPOSAL NO. 213

**DESCRIPTION:** Continue to allow single-strand nylon gillnet web in Cook Inlet. **DISCUSSION:** No action based on action taken on proposal 214.

#### PROPOSAL NO. 214

**DESCRIPTION:** Allow use of monofilament gillnet.

**AMENDMENT:** Include one 35-fathom set gill net in Cook Inlet area. Sunset December 31, 2007. **DISCUSSION:** Both set and drift gillnet fishermen may participate in this experimental fishery. Commissioner will have the ability to use emergency order if the department finds there are adverse effects by the use of this gear.

**DESCRIPTION:** In Kenai and Kasilof sections of the Upper Subdistrict, a set gillnet may not be more than 29 meshes in depth.

**DISCUSSION:** This would be a drastic change in the set net fishery creating potential economic loss and financial burden to restructure nets.

**DISCUSSION:** Board prefers the use of a commissioner's permit to conduct experimental fisheries. Concern was expressed of adding another user to a fully-allocated fishery. Although the pink salmon are underutilized, these streams are some of the most popular streams in the United States, and therefore, would not be a good location for this type of test fishery. A concern of bycatch was expressed, as well as the fact that the price of pinks is low at this time.

#### PROPOSAL NO. 219

**DESCRIPTION:** Decrease amount and length of set gillnets allowed.

**DISCUSSION:** There is a long history of economic importance to the region and to the state in these fully-allocated fisheries. Board attempts to improve the management of these fisheries with its actions, as well as maintain a balance in the allocation.

#### **PROPOSAL NO. 220**

**DESCRIPTION:** Report commercially- and sport-caught chinook by the same standard. **DISCUSSION:** Information on chinook catch is collected in the commercial fishery by processors.

A conservation concern of no reporting requirement on jack salmon in the sport fishery was expressed; however, there are monitoring efforts by the department for this issue.

#### PROPOSAL NO. 221

**DESCRIPTION:** Allow the formation of setnet coops including up to ten permits.

**DISCUSSION:** There is a regulation in place for Kodiak to form joint ventures for two permit holders. The intent was to legalize allowing one permit holder to sign off on the fish ticket, not to create an absentee owner situation. This may require some statutory changes.

#### PROPOSAL NO. 222

**DESCRIPTION:** Allow drift nets to go partially dry and remain a legal gillnet.

**DISCUSSION:** No action due to the request to withdraw by proponent. The board noted that allowing nets to go dry could create an enforcement problem.

#### PROPOSAL NO. 223

#### **ACTION:** Carried

#### PROPOSAL NO. 227

**DESCRIPTION:** Establish 56/44 harvest rate as a goal in Upper Cook Inlet management plan. **DISCUSSION:** Currently no allocation percentages are in regulatory language. The runs vary, so allowances for future allocations would need to be considered.

#### PROPOSAL NO. 228

**DESCRIPTION:** Allow more fishing time in the Northern District. **DISCUSSION:** No action based on action taken on proposal 184.

#### PROPOSAL NO. 229

**DESCRIPTION:** Allow formation of coops.

**DISCUSSION:** The board's salmon restructuring panel is currently reviewing this issue and the board preferred to wait until recommendations might be seen from that panel.

#### PROPOSAL NO. 230

**DESCRIPTION:** Create an early season fishery in the Kalgin Island Subdistrict. **AMENDMENT:** Open the west side of Kalgin Island and provide a boundary description **DISCUSSION:** An early season will provide an opportunity for setnetters. Many of the participants will be direct marketing to the Anchorage market. The provision of a cap of 1,000 will prevent an

overharvest of kings.

**DESCRIPTION:** Return management plan to pre-1999.

**AMENDMENTS:** Delete the "guiding principles" for Upper Cook Inlet salmon.

The requirement of use of guiding principles that are already covered in other policies in regulation instead creates more of a hardship in the board process and serves no meaningful purpose.

**AMENDMENTS:** In Kenai River drainage lakes and ponds: two fish per day, only one fish over 20 inches; no annual limit. In flowing waters above Skilak Lake: one fish per day, maximum size limit of 16 inches; open season June 11-May 1; no annual limit. In flowing waters below Skilak Lake, including Skilak Lake: one fish per day, maximum size limit of 18 inches; no annual limit; no closed season.

**DISCUSSION:** Skilak Lake is a natural divider of the upper and lower Kenai River. Biological data indicates a sustainable surplus for harvest on this stock and this lends consistency to regulations on this fishery.

#### **PROPOSAL NO. 265**

**DESCRIPTION:** Make uniform Dolly Varden bag and possession limits. **DISCUSSION:** No action based on action taken on proposal 264.

#### PROPOSAL NO. 266

**DESCRIPTION:** Make uniform Dolly Varden seasons, bag and possession limits. **DISCUSSION:** No action based on action taken on proposal 264.

#### PROPOSAL NO. 267

**DESCRIPTION:** Modify Dolly Varden season to protect rainbow trout spawning beds. **DISCUSSION:** No action based on action taken on proposal 264.

**DESCRIPTION:** Close the outlet of Skilak Lake to fishing.

**DISCUSSION:** Department of Natural Resources regulations stipulate that no one may anchor a boat such that it obstructs the primary traffic channel from mid-May through July. Board probably lacks authority to implement this proposal.

**DESCRIPTION:** Change the legal hook gap to 3/8 inch or less in the upper Kenai River.

AMENDMENTS: From June 11-May 1, the Kenai River from Skilak Lake, including the waters of Skilak Lake within one-half mile radius of the Kenai River inlet, upstream to the Sterling Highway bridge at Mile Post 53, only one single hook with a hook gap between point and shank of threeeighths inch or less; intent is to include the Russian River.

**DESCRIPTION:** Close the Russian River to fishing between 11 p.m. and 6 a.m. **DISCUSSION:** No action based on action taken on proposal 273.

#### **PROPOSAL NO. 275**

**DESCRIPTION:** Establish a closed fishing zone within the Russian River Sanctuary. **DISCUSSION:** There is no biological concern to warrant this action.

#### Kenai River

**PROPOSAL NO. 276 ACTION:** No action **DESCRIPTION:** Prohibit fishing from a motorized vessel on the Kenai River. **DISCUSSION:** No action based on action taken on proposal 278.

#### PROPOSAL NO. 277

DESCRIPTION: Prohibit fishing from a motorized vessel on the Kenai River on Mondays, Wednesdays and Fridays during the king salmon season.

**DISCUSSION:** No action based on action taken on proposal 278.

#### PROPOSAL NO. 278

**DESCRIPTION:** Prohibit fishing from a motorized vessel between Skilak Lake and the Soldotna Bridge on Wednesdays during the king salmon season.

**DISCUSSION:** Kenai River drainages do not currently have facilities that could support a driftonly fishery. It could create congestion in relatively few fishing locations downstream of the Sterling Highway Bridge crossing at Soldotna. The board found that this action is much too restrictive covering a large section of the Kenai River.

#### PROPOSAL NO. 279

**DESCRIPTION:** Allow fishing from vessels equipped with 50 horsepower four-stroke motors. DISCUSSION: The Department of Natural Resources is the entity with authority to regulate horsepower within the Kenai River Special Management Area. Board lacks authority.

#### **PROPOSAL NO. 280**

**ACTION:** No action **DESCRIPTION:** Prohibit nonresidents from fishing from a boat for king salmon downstream from Skilak Lake.

**DISCUSSION:** No action based on action taken on proposal 281.

#### PROPOSAL NO. 281

#### **ACTION: Carried as amended**

**DESCRIPTION:** Eliminate the prohibition of nonresidents fishing from a boat on the Kenai from 6:00 pm to 6:00 am.

**DESCRIPTION:** Develop allocations between guided/nonguided and resident/nonresident anglers. **DISCUSSION:** Resident /disabled anglers who choose to fish with guides may be adversely affected by guide restrictions. However, separate allocations may not increase unguided and/or resident effort and harvest. There is work in progress by the user groups in the area. Logbook and licensing requirements of guides will assist the board in evaluating this fishery at subsequent meetings. There will be some additional benefit to residents and unguided anglers during the time periods stated in proposal 295.

#### PROPOSAL NO. 284

**DESCRIPTION:** Extend time and area of early-run king salmon slot limit.

**DISCUSSION:** There is no conservation concern for late run 5-ocean fish. The slot limit was implemented for early-run fishery to allow the age composition of the catch to mirror or more closely reflect the age composition of fish returning to the river. The slot limit extension might be a regulatory mechanism that restricts participation (i.e., public does not care to fish if not allowed to keep a big fish).

#### PROPOSAL NO. 285

**DESCRIPTION:** Allow bait in the early-run king salmon fishery when the projected escapement is in the upper half of the BEG range.

**DISCUSSION:** Allowing bait will not allow the escapement number to be close to the upper end of the escapement goal range. There would be a biological concern of harvest more fish.

#### PROPOSAL NO. 286

**DESCRIPTION:** Increase the length limit of jack king salmon to 28 inches or less; set new bag and possession limits.

**DISCUSSION:** Almost all king salmon in the Kenai River returns that are between 20 and 28 inch are 2-ocean fish. The female component of fish 28 inches and under is believed to be somewhere around 35 percent. A small percentage of those fish could be classified as spawners. It is believed there would be a minimal additional harvest of around 400-500 fish. The larger female fish found in commercial harvest are more full of eggs. The length established in defining a jack salmon was originally to allow additional harvest on a statewide basis. Board expressed concern of going back to redefine a jack salmon system by system.

#### PROPOSAL NO. 287

**DESCRIPTION:** Prohibit fishing for jack salmon in waters closed to large salmon.

**DISCUSSION:** Areas closed to fishing for king salmon 20 inches or greater in length and other salmon 16 inches or greater in length are intended to protect spawning fish while allowing the harvest of smaller 1-ocean jack salmon. While creating harvest opportunity, the regulation renders salmon closures unenforceable because anglers have targeted large king salmon claiming they are fishing for jacks. Enforcement personnel can do little to protect the resource in these cases.

#### PROPOSAL NO. 288

**DESCRIPTION:** Prohibit the use of bait above the Soldotna Bridge until August 31.

**DISCUSSION:** There are conflicts with coho salmon fishing regulations in this section of the Kenai River. There is no biological concern to restrict bait and this would restrict fishing opportunity.

**AMENDMENT:** Provide opportunity for sockeye salmon fishing within the sanctuary areas of the Funny River, Slikok, Moose Rivers and Wally's Third Hole. The area is designated as fly fishing only and gear is restricted as defined in 5 AAC 75.024. No fishing from vessels, no retention of king salmon.

**DISCUSSION:** Management plans have been conservatively structured to constrain the ability of the angling public to harvest early-run stocks at sustainable levels while still providing for fishing opportunity. Exploitation rates during past seasons have exceeded 60 percent. This will provide a fishing opportunity for sockeye harvest. It is biologically justifiable because it will not increase exploitation on king salmon spawning in these areas.

#### PROPOSAL NO. 293

#### **ACTION:** Failed

**DESCRIPTION:** Close area between Upper Killey River to Skilak Lake to fishing for king salmon. **DISCUSSION:** Closing the area is not necessary as a conservation measure, and would close four miles of river to fishing. This could cause more crowding of anglers who normally are fishing over four miles of river into Killey River area.

#### PROPOSAL NO. 294

ACTION: Failed

**DESCRIPTION:** Close area between Upper Killey River to Skilak Lake to fishing for sockeye salmon during August.

**DISCUSSION:** The area does have spawning fish but is a pass through area, and a high priority area for fishing for sockeye salmon. Anglers do not harvest spawning fish in this area. There is no conservation concern.

#### PROPOSAL NO. 295

#### ACTION: Carried as amended

**DESCRIPTION:** Increase the coho bag and possession limit to three fish; open fishing for king and coho salmon Aug. 1-3 for unguided, resident anglers.

**AMENDMENT:** Allow anglers to continue to fish for coho after they retain their bag limit from the Soldotna bridge to regulatory markers at Skilak Lake. No bait Sept 1 – Dec 31 in the Kenai River from the mouth of the Upper Killey River upstream to the ADF&G regulatory markers at the outlet of Skilak Lake. The department may extend the king salmon season by emergency order, for the first seven days in August if the escapement goal for king salmon is projected to be exceeded.

**DISCUSSION:** Coho salmon are in a period of recovery, and a daily limit increase is not warranted. Anglers do not need to fully utilize coho or increase exploitation. A bag limit of two has contributed to the recovery. This regulation will allow additional opportunity in a catch-and-

release fishery. This is already occurring on the river, as fishers catch and release through the day, until later, then keep their second fish.

#### PROPOSAL NO. 296

**DESCRIPTION:** Close sport fishing on the Kenai River from 11 p.m. to 6 a.m. **DISCUSSION:** The board saw this action as too broad.

#### PROPOSAL NO. 297

**DESCRIPTION:** Allow children to fish for "mud fish." **DISCUSSION:** The board stated this would be difficult to enforce.

#### PROPOSAL NO. 298

**DESCRIPTION:** Prohibit nonresidents from exporting more than 125 pounds of fish. **DISCUSSION:** No action based on action taken on proposal 250.

#### Kenai River Guides

PROPOSAL NO. 299

#### **DESCRIPTION:** Apply guided fishing requirements to rented and leased boats.

**DISCUSSION:** Board does not have authority to regulate based on whether the boat is owned or leased. This would create a reduced opportunity for public participation, as it would restrict resident anglers that rent boats for fishing on guide days during guide hours (6:00 a.m. to 6:00 p.m., Tuesday-Saturday). Rental boats would need to be marked in some way to distinguish them on the river. There is no way to quantify the magnitude of the problem and no way to enforce.

#### PROPOSAL NO. 300

**DESCRIPTION:** Apply guided fishing requirements to rented and leased boats. **DISCUSSION:** No action based on action taken on proposal 299.

#### PROPOSAL NO. 301

It is easier to regulate presence and/or fishing activity. This creates a regulatory complexity that could be added to existing Department of Natural Resources Kenai River Special Management Area guide stipulations. There are limited boat launch sites on the river.

#### PROPOSAL NO. 302

**DESCRIPTION:** Prohibit guide boats from being underway on the river prior to 6 a.m. **DISCUSSION:** No action based on action taken on proposal 301.

#### **PROPOSAL NO. 303**

**DESCRIPTION:** Prohibit guide boats from being on the river between 5:50 a.m. and 6:10 p.m. **DISCUSSION:** No action based on action taken on proposal 301.

#### PROPOSAL NO. 304

**DESCRIPTION:** Restrict guided anglers to drift boats only on Mondays and Tuesdays in 2004, add another day each year until 2009; restrict hours when fishing from a guided vessel is allowed. **DISCUSSION:** This proposal is too restrictive. There is a lack of infrastructure to support a drift boat only fishery and it conflicts with unguided anglers on "drift boat only" Mondays.

**DESCRIPTION:** Prohibit fishing from a guided vessel on Sundays, Mondays, or Wednesdays during the king salmon season.

**DISCUSSION:** This prohibition would create a 20 percent reduction in guided angler hours when there is no biological need, and could affect resident anglers.

#### PROPOSAL NO. 306

**DESCRIPTION**: Allow residents to fish from a guided vessel on Sundays and Mondays during the king salmon season and on Mondays in August.

**DISCUSSION:** Disability exemptions already exist in regulation. The department handles claims on a case-by-case basis through a commissioner's permit as consistent with the American with Disabilities Act. Residents and/or disabled people have 60 hours per week to fish from registered guide boats.

#### PROPOSAL NO. 307

**DISCUSSION:** This would allow for an increased total number of guided anglers (same number of boats with one more angler per boat) which could lead to an increase in harvest. More weight in the boat, and the potential larger horsepower engine needed, could cause larger wakes.

**DESCRIPTION:** Require commercial operators to complete a freshwater logbook. **DISCUSSION:** No action based on action taken on proposal 253.

**DESCRIPTION:** Create a personal use management plan for Upper Cook Inlet.

DISCUSSION: Department already has a personal use management plan which liberalizes the personal use fishery with additional time per area. Current data indicates that a maximum of 16 percent of households attain their bag limit. An abundance-based liberalization would also be difficult for the department to manage because of differing inriver and optimal escapement goals described in the Kenai River late run sockeye salmon management plan.

**DESCRIPTION:** Open a portion of Alexander Creek to catch-and-release only fishing.

**DISCUSSION:** Currently, escapement levels are low, and there is a high level of pike predation. This is the earliest dosed king salmon fishery in the area. The population cannot provide for catch-and-release mortality.

#### PROPOSAL NO. 340

**DESCRIPTION:** Close the Alexander Creek drainage to king salmon fishing. **DISCUSSION:** The resource can handle the current catch-and-release level that is taking place.

PROPOSAL NO. 341

**DESCRIPTION:** Close the mouth of Alexander Creek to king salmon fishing. **DISCUSSION:** No action based on action taken on proposal 340.

#### PROPOSAL NO. 342

**DESCRIPTION:** Create a Deshka River King Salmon Management Plan.

**DISCUSSION:** The proposal could increase catch-and-release mortality on spawning king salmon, especially because water temperatures are warming. By the end of July, 99 percent of the fish have passed the weir. Most are looking very red and ready to spawn. Most of the fish that would be harvested are fish that should not be harvested because they are on the spawning grounds. Board prefers to protect this small group of fish that arrive this late.

**DESCRIPTION:** Reduce season and hours of all fisheries on eastside of Susitna River drainage. **DISCUSSION:** This restricts the eastside sport opportunities unnecessarily. Board did not see a biological reason to close the fishery. This could increase over-crowding.

**DESCRIPTION:** Increase waters of the Kashwitna River drainage open to king salmon fishing.

**DISCUSSION:** Coho and rainbow trout fishing is already open in these areas. Landowners in the area will be able to harvest a king salmon from their property. No trespass problems have been documented. This will provide additional opportunity; the existing harvest of king salmon is fairly small.

#### PROPOSAL NO. 352

**DESCRIPTION:** Amend the king salmon season in Unit 2 of the Susitna River drainage. **DISCUSSION:** No action based on action taken on proposal 350.

#### PROPOSAL NO. 353

**DESCRIPTION:** Expand time when multiple hooks are allowed in Unit 2 of Susitna River drainage. **DISCUSSION:** Current regulations protect rainbow trout.

#### PROPOSAL NO. 354

**DESCRIPTION:** Expand the season that multiple hooks are allowed in the Lake Creek drainage. **DISCUSSION:** This is basically a housekeeping proposal that brings consistency to regulations.

#### PROPOSAL NO. 355

**DESCRIPTION:** Reduce bag and possession limit of sockeye salmon and prohibit guided fishing on weekends in the Larson Creek drainage.

**DISCUSSION:** There is very little guiding on Larson Creek. Effort is primarily from transporters in this drainage. There is no biological concern.

#### PROPOSAL NO. 356

**DESCRIPTION:** Reduce bag and possession limit of sockeye salmon, prohibit guided fishing on weekends, and eliminate the 1,000 foot fishing restriction from mouth of Larson Creek drainage. **DISCUSSION:** No action based on action taken on proposal 355.

**DESCRIPTION:** Allow catch-and-release king salmon fishing in eastside Susitna River streams. **DISCUSSION:** Most of these systems are on the road system, in high use areas. **DESCRIPTION:** Change limit of king salmon season in the Chulitna River.

**DISCUSSION:** This fishery is already the most liberal of the eastside fisheries and a change may put stocks in small tributaries at risk.

**DESCRIPTION:** Increase waters open to king salmon fishing in the Chulitna River.

**DISCUSSION:** Increasing open waters may pose enforcement difficulties. There likely is not a harvestable surplus of the small stocks.

#### PROPOSAL NO. 360

**DESCRIPTION:** Allow the use of bow and arrow to harvest sockeye salmon in Crescent Lake. **DISCUSSION:** The board found no need to provide this gear for salmon; hook and line is sufficient.

**DESCRIPTION:** Prohibit fishing for jack salmon in waters closed to large salmon.

**ACTION:** No action **DESCRIPTION:** Increase the bag limit for salmon, other than king salmon, in Susitna River drainage and Knik Arm fresh waters.

**DISCUSSION:** No action based on action taken on proposal 365.

#### Knik Arm

PROPOSAL NO. 371

**DESCRIPTION:** Restrict season of all fisheries in the Little Susitna River drainage. **DISCUSSION:** Current regulations provide opportunity and there is no conservation concern for these stocks.

#### PROPOSAL NO. 372

**DESCRIPTION:** Prohibit fishing in all flowing waters of the Palmer/Wasilla zone. **DISCUSSION:** There are no conservation concerns. Currently, these are some of the most restrictive regulations in the area. The board also referenced its discussions under proposal 371.

#### PROPOSAL NO. 373

**DESCRIPTION:** Open the Eklutna Tailrace to fishing for kings 20 inches or greater in length. **DISCUSSION:** The department has a successful program that provides opportunity for stocked fish. This takes pressure off of wild stocks. Without this proposal, there would be no opportunity to fish on these stocked fish.

#### PROPOSAL NO. 374

**DESCRIPTION:** Open the Eklutna Tailrace to fishing for kings 20 inches or greater in length. **DISCUSSION:** No action based on action taken on proposal 373.

**DISCUSSION:** This is a housekeeping proposal. There are no wild trout stocks in the Matanuska River. This system carries one of the highest silt loads in the state.

#### PROPOSAL NO. 383

#### **ACTION:** Failed

**ACTION:** Carried

**DESCRIPTION:** Modify hook requirements in fly-fishing only waters.

**DISCUSSION:** There is only one fly fishing "only" area in the Northern Cook Inlet Management Area (Wolverine Creek). Provisions are already provided for in regulation. There are no trout conservation concerns at Wolverine Creek. This is overly restrictive.

#### **PROPOSAL NO. 384**

**DESCRIPTION:** Prohibit retention of grayling in the Prairie Creek drainage.

**DISCUSSION:** Rainbow in this drainage is already catch-and-release. In spite of lowering the bag limit from five to two, the stocks appear to continue to decline.

#### **PROPOSAL NO. 385**

### **DESCRIPTION:** Allow the use of gillnets to harvest northern pike.

**DISCUSSION:** Although the department supports efforts to harvest northern pike, this would require the department to assess all lakes thought to contain pike. The department could not feasibly provide estimates of pike and other lake species abundances on every lake.

#### West Cook Inlet

PROPOSAL NO. 386

**DESCRIPTION:** Allow a harvest of king salmon on the Theodore River.

**DISCUSSION:** This year's escapement was below the bottom end of the sustainable escapement goal range. Additional harvest on this river would not be sustainable.

#### PROPOSAL NO. 387

**ACTION:** Failed

**DESCRIPTION:** Prohibit the retention of king salmon in the Chuitna River on Mondays, Wednesdays, and Fridays.

**DISCUSSION:** There are no conservation concerns for king salmon in this river.

#### PROPOSAL NO. 388

#### **ACTION:** Failed

**ACTION:** Failed

**DESCRIPTION:** Prohibit filleting of fish within one-half mile of Wolverine Creek confluence.

**DISCUSSION:** The Wolverine Creek Committee put together a set of guidelines which includes not cleaning fish within one-half mile of confluence. It is working well, and the problem is clearing up. The board found no need to put this provision into regulation.

#### PROPOSAL NO. 389

**DESCRIPTION:** Designate a portion of Silver Salmon Creek as fly-fishing only waters. **DISCUSSION:** There is very little effort in this area; no conservation concerns exist.

#### SPORT FISHING—OTHER

#### PROPOSAL NO. 23

#### **ACTION: Failed**

**DESCRIPTION:** Prohibit catch-and-release fishing when there is a conservation concern. **DISCUSSION:** The board previously considered this proposal at the November 2004 meeting for the Lower Cook Inlet areas and voted against it. The board does not wish to remove this as a tool for the department to manage the fishery.

#### MISCELLANEOUS BUSINESS

#### Stock of Concern

Board removed Fish Creek sockeye salmon as a stock of yield concern when it reviewed the stock according to the Sustainable Salmon Fisheries Policy.

#### <u>OEG</u>

Board changed to 5,300 as the lower end range optimal escapement goal on Kenai River earlyrun king salmon

#### **Emergency Petition** Transboundary River Chinook salmon (Southeast Area)

There is a harvestable surplus that would be foregone if action is not taken at this time. The board moved to add final action to its March 2005 meeting agenda.

#### Letter to Kenai Peninsula Brown Bear Committee

Request from Cooper Landing AC, to express support to the Kenai Peninsula Bear Committee for its efforts in addressing human/bear conflict on the Russian River. Board agreed to send a letter.

#### Request to Support Increased Level of Fines

Board received a request to express recommendation for a mandatory minimum fine of \$500 for failure to record a king salmon harvested from the Kenai River on a sport fishing license. This is similar to wanton waste fines in wildlife violations. Although they supported the concept, the board wanted more information and tasked member Bouse to work with enforcement on final recommendation.
