fishing seasons, opening and closing times; harvest levels or quotas; districts, subdistricts, sections, subsections, areas, and other management boundaries; locations open or closed to fishing; methods and means; gear and vessel restrictions, marking and identification, definitions, operational requirements, registration and permit requirements; permits, harvest records, fish tickets; management plans for conservation and development of fisheries; allocation among beneficial uses; cooperative fisheries; possession, transport, or release of fish; regulation of fishing as needed for the conservation, development, or utilization of fisheries.

All other provisions posted in the October 27, 2005 Notice of Proposed Changes and the January 11, 2006 Supplemental Notice remain the same and, including the public comment periods and tentative meeting schedule.
