




Alaska Pacific Cod Fisheries:



- Federal: Federal waters (EEZ; 3–200 nmi) guided by NPFMC process.
- Parallel: State waters (0–3 nmi) concurrent with adjacent federal fishery and generally adopt federal regulations and management measures as guided by BOF process.
- State-Waters (GHL): State waters (0–3 nmi) guided by BOF process.


Harvest Limits

- ABC Acceptable Biological Catch (NMFS: EGOA, CGOA, WGOA, BSAI)
- TAC Total Allowable Catch (Federal/Parallel Fishery)
- GHL Guideline Harvest Level (State-Waters Fishery)



Federal Pacific Cod Fishery

- Federal waters 3 to 200 nmi
- Harvest limit (TAC) based on 75% of Pacific cod ABC
- Gear sectors: Trawl, longline, pot and jig gear
- A & B seasons (Jan 1 and Sept 1)
- No gear limits, vessel length limited to 125 ft (GOA)
- Limited access (FFP and LLP required)
- Observer requirements




Parallel Pacific Cod Fishery

- State waters 0 to 3 nmi
- Opened concurrent to federal fishery by state EO
- Shared TAC with federal fishery
- Gear sectors: Trawl, longline, pot and jig gear (bottom trawl restrictions)
- A & B seasons (Jan 1 and Sept 1)
- No gear limits but <u>some</u> vessel
 length restrictions (58 ft maximum Chignik & S. Peninsula)
- Open access (FFP/LLP <u>not</u> required)
- Observer requirements for federally permitted vessels



State-Waters Pacific Cod Fishery

- State waters 0 to 3 nmi
- Harvest limit (GHL) based on 25% of Pacific cod ABC (3% Aleutian Is)
- Seasons open after federal/parallel fisheries close
- Pot and jig gear (longline PWS ; longline and trawl Aleutian Is)
- Gear limited to 60 pots or 5 jig machines
- Some vessel length limits (58 ft maximum Chignik & S. Peninsula)
- Open access
- Registration exclusivity
- No observer requirements




October 2013 Statewide Pacific Cod Meeting

- **37 Proposals**
- Proposal Category:
- Increase state-waters Pacific cod GHLs (9 proposals)
- Create new state-waters fisheries (4 proposals)
- Pacific cod management plans (17 proposals)
- General (7 proposals)

Current state-waters GHL + 10-yr average catch from parallel fishery


Proposals 3-5: Increase Chignik Area GHL

- Proposal 3: Increase GHL to 17.5% of Central GOA ABC
- Proposal 4: Increase GHL to 17.0% of Central GOA ABC
- Proposal 5: Increase GHL based on state-waters + parallel catch


8.75% increase = **11.0 million pounds** (2012 ABC) 0.30% increase = **0.38 million pounds** (2012 ABC)

Proposals 18-21: Increase South Alaska Peninsula GHL

- Proposals 18-20: Increase GHL to 50% of the Western GOA ABC
- Proposal 21: Increase GHL to 55% of the Western GOA ABC



25% increase = **15.5 million pounds** (2012 ABC)
