Commercial Fishery (8)

Pot Shrimp Fishery (8)

Miscellaneous Shellfish (5 Proposals)

Sea Cucumbers (3)

- 109 Reduce fishing time for commercial sea cucumber fishery in November.
- 110 Allow permit stacking and increased trip limit for commercial sea cucumber fishery.
- 108 Clarify open fishing periods for commercial sea cucumber fishery.

Geoducks (2)

- 111 Allow the department to establish trip limits for commercial geoduck fishery.
