<u>PROPOSAL 2</u> – 5 AAC 92.050. Required permit hunt conditions and procedures. Provide the Commissioner the authority to transfer spring black bear drawing permits for Units 1-3 and 14C (JBER), and spring brown bear drawing permits for Units 4, 8, 10, 14C, 22 and 26B to future hunting seasons.

**PROPOSED BY:** Alaska Board of Game

**WHAT WOULD THE PROPOSAL DO?** The following additional regulatory language would be adopted under (6) of the current regulations:

(C) a person that is unable to hunt a black bear in Units 1–3 and 14C (JBER) or brown bear in Units 4, 8, 10, 14C, 22, or 26B drawing permit hunts for the regulatory year 2019 spring season due to health mandates limiting travel, may have the permit transferred to a future spring season at the discretion of the Commissioner; this section will sunset July 1, 2023.

#### WHAT ARE THE CURRENT REGULATIONS?

- 5 AAC 92.050. Required permit hunt conditions and procedures
  - (a) The following conditions and procedures for permit issuance apply to each permit hunt:

•••

- (5) except as provided in (6) of this subsection, a permit is nontransferable; however, the department may reissue an invalidated Tier II subsistence hunting permit to the highest-ranked applicant remaining in the original pool of eligible applicants;
- (6) the commissioner may reissue or transfer a permit as follows:
  - (A) a permit may be transferred for scientific purposes;
  - (B) a person that is on active duty in a branch of the military under United States Department of Defense deployment orders to a combat zone designated by executive order issued by the President of the United States and that has been issued a:
    - (i) drawing permit, and is prevented from using the drawing permit due to being out of the state on active duty, may be reissued the same drawing permit when the person returns to this state from active duty under this subparagraph, under procedures set out in the applicable permit hunt supplement;
    - (ii) Tier II permit may transfer that Tier II permit only during the same regulatory year to a substitute resident hunter while the person is out of the state on active duty under this subparagraph, under procedures set out in the applicable permit hunt supplement;

#### WHAT WOULD BE THE EFFECT IF THE PROPOSAL WERE ADOPTED?

If adopted, this proposal will provide the Commissioner the authority to transfer nonresident bear drawing permits to future regulatory years. An emergency order (EO) was issued April 1, 2020 closing all bear hunting seasons in the State of Alaska. A subsequent EO was issued April 2, 2020 allowing for resident hunting while maintaining the closure of nonresident bear seasons. This proposal would provide the mechanism necessary to reallocate drawing permits and provide hunting opportunity for hunters who were unable to hunt in spring 2020 due to EO closures.

**BACKGROUND:** Due to current health mandates around the United States associated with COVID-19 both resident and nonresident brown bear hunters are unable to fully utilize spring 2020 (regulatory year 2019) hunting opportunities. While most bear hunts are administered through drawing permits, Unit 9 brown bear hunts are managed by registration permit. Fall hunts are offered only in odd numbered years (e.g., 2019), and spring hunts are offered only in even numbered years (e.g., 2020). See department comments for Proposal 1 for information for Unit 9 brown bear hunts.

Drawing permits are used by managers to closely manage harvest for a variety of species. The number of available permits is consistent with sustained yield. Proposal 2 is specific to bear drawing permit hunts across Alaska. Permit numbers have been established for each of these hunts. Moving permits between regulatory years without adjusting permit numbers will create biological concern for some hunts where effort and success is high. In other hunts, drawing permits are often undersubscribed, or effort and success is low, and adding additional permits to an upcoming regulatory year will have minimum impacts. The department considered these factors when providing recommendations on permit transfers for hunts identified in the proposal.

**DEPARTMENT COMMENTS:** The department is **NEUTRAL** on the regulatory changes of this proposal and is **NEUTRAL** on the allocative aspects of this proposal. The department anticipates a cost of approximately \$30,000 in programming and staff time to administer drawing permits out of the awarded year. There are many aspects to this process that are not clearly defined and it is difficult to ensure that permit holders will be treated equitably while implementing the board's intentions in an efficient manner. In addition, with adoption of this proposal the board will set a precedent and it is likely that future permit holders will request similar actions when unforeseen circumstances preclude them from hunting.

This proposal does not address application, license, or tag refunds. Refund decisions are the purview of the department and are assessed through the Division of Licensing.

If the board adopts this proposal, the department has the following regional recommendations for the drawing hunts:

At the January 2019 board meeting the board repealed several black bear drawing hunts in Southeast, Alaska. Drawing hunts identified above remain under drawing hunt management because of their popularity and combining Spring 2020 and Spring 2021 hunts is likely to result in unsustainable harvests. Much of Southeast is available to all bear hunters under general season harvest tickets hunts for black bears and registration hunts for brown bears. The black bear hunts listed above remain under drawing hunt management because of their popularity, and with recent increases in permits issued now offer maximum sustainable harvest opportunity.

If the board chooses to adopt this proposal, the department recommends transferring spring 2020 drawing permits to spring 2022 due to concerns about unsustainable harvest that could occur if Spring 2020 permit holders hunt at the same time as spring 2021 permit holders. Permits for Spring 2021 have already been awarded. Providing Spring 2021 hunt opportunities for Spring 2020 permit holders may also result in a significant annual increase of black bear harvest and

hunters in the region. While this increase is only expected for one year, it creates concerns with crowding and hunt quality. The impact of combining the two seasons will be magnified due to an increase in permits available in each of the remaining draw hunts which were adopted by the board at the January 2019 meeting in Petersburg.

#### Region II (Southcentral Region)

No regulatory changes are necessary for Unit 14C brown and black bear drawing hunts. Hunts open in the fall and remain open through the spring of the following calendar year. There is only 1 nonresident permit holder for all these hunts; residents could hunt in spring 2020. Several of these hunts occur on Joint Base Elmendorf Richardson (JBER) and hunt area closures are routine for military operations. The department communicates readily with base officials, but closure decisions are made by the U.S. Department of Defense and may limit hunt opportunity when seasons are open.

#### **Unit 8** (resident & nonresident)

If the board chooses to adopt this proposal, the department recommends transferring nonresident spring 2020 drawing permits to spring 2021 and foregoing the fall 2020 drawing application period. While the interim time period may make it difficult for both hunters and guides to finalize schedules, no permits have been awarded for this time period at this time and additional harvest is not warranted in spring 2021. The department recommends transferring all unhunted resident drawing permits to spring 2022; spring 2021 resident drawing permits have been awarded. Combining spring 2020 and spring 2021 may result in excessive annual harvest, increased female harvest, increased harvest of lower age groups, and creates concerns with crowding and hunt quality. In addition, Unit 8 brown bear hunters can take advantage of overthe-counter registration permits along the Kodiak road system.

#### Region III (Interior & Northeast Arctic Region)

No regulatory changes are necessary in Region III. There is only 1 nonresident bear drawing hunt (DB987) in Unit 26B. The hunt opens in the fall and remains open through the spring of the following calendar year. All hunters have reported for the RY19 regulatory year.

#### Region IV (Central & Southwest Region)

If the board chooses to adopt this proposal, the department recommends transferring spring 2020 drawing permits to spring 2021. Based on historical harvest data an increase in harvest is not expected to create a significant biological concern. Brown bear hunts in Unit 10 are logistically challenging and expensive which limits the overall number of hunters participating in the hunts.

#### Region V (Western & Northwest Arctic Region)

If the board chooses to adopt this proposal, the department recommends transferring the spring 2020 drawing permits to spring 2022 (RY2021). Both nonresident brown bear drawing hunts (DB685 & DB690) have regulatory language limiting the number of permits available. Twenty-seven permits for DB685 can be issued, and 21 permits for DB690 can be issued. The number of permits for DB690 was increased at the 2016 statewide board meeting and an additional 9 permits were made available as undersubscribed permits during RY2016. In RY2020, there are currently 24 DB685 and 20 DB690 permits available as undersubscribed permits. There are no permits required for resident hunters in these areas: only the nonresident hunters hunt under a draw permit.

<u>COST ANALYSIS:</u> Adoption of this proposal is expected to result in significant additional costs to the department. Exact dollar amounts are difficult to estimate, and initial analysis estimates the cost to begin at approximately \$30,000. Most incurred costs will be associated with staff time required to accomplish the following:

- Programming staff time to identify and transfer permits appropriately. This is compounded by the need to program for multiple years (2021 and 2022).
- Staff to track reallocated permits; and
- Staff to track spring 2020 vs. future regulatory year hunting effort.
