EXPLANATION:

This emergency order closes the State of Alaska resident and non-resident deer hunting season for does (female deer) in the area encompassing the Northeast Chichagof Controlled Use Area (Unit 4, the area consists of that portion of Unit 4 on Chichagof Island north of Tenakee Inlet and east of the drainage divide from the northwest point of Gull Cove to the Port Frederick Portage, including all drainages into Port Frederick and Mud Bay); and mainland portions of Chichagof Island on the east half of Lisianski Inlet to the head of Lisianski River, continuing NE to the eastern most point of Goose Flats in Tenakee Inlet. This emergency order takes effect at 11:59 PM, October 25, 2012. This hunt area is located within Game Management Unit 4. This emergency order does not affect the deer hunting regulations in the remainder of Game Management Unit 4.

REGULATION:

Therefore, the provisions of **5 AAC 85.030, Hunting seasons and bag limits for deer**, are superseded by this emergency order, and the following provisions are effective:



JUSTIFICATION:

This emergency order closes doe hunting on a portion of northern Chichagof Island defined as the Northeast Chichagof Controlled Use Area (NECCUA). Record snowfall during the winter of 2006-07 that persisted into late spring, resulted in substantial winter kill of deer. Similar winter weather occurred again in 2007-08 and 2008-09, delaying a substantive recovery. Staff from the Department of Fish and Game’s Division of Wildlife Conservation conducted deer mortality and condition surveys throughout the region in the late winters and springs of 2007-2011. These surveys indicate locations in northern Southeast Alaska, including NECCUA and adjacent areas , are experiencing continued cumulative effects from the four consecutive hard winters and winter-related deer mortality. A net gain in over-winter deer survival and fawn recruitment was not recorded until spring, 2010. Field work in 2012 on Northeast Chichagof indicates a recovering population, but

remains at a significantly reduced level from what existed in 2006. On NECCUA, roads allow vehicle access into all major watersheds, resulting in a popular deer hunting area for local and non-local hunters. Additional doe harvest jeopardizes the future recovery of the population.
