# Emergency Order

### **EXPLANATION:**

This emergency order supersedes Emergency Order No. 2-KS-7-04-13, issued April 18, 2013. This emergency order prohibits king salmon fishing (including catch-and-release) while sport fishing within one mile of shore in the salt waters of Cook Inlet south of the latitude of the mouth of the Ninilchik River (60° 03.99' N. lat.) to the latitude of Bluff Point (59° 40.00' N. lat.). King salmon incidentally caught while fishing for other fish may not be removed from the water and must be released immediately. This emergency order is effective from 12:01 a.m., Saturday, June 15, 2013, through 11:59 p.m., Monday, July 15, 2013.

### **REGULATION:**

The provisions of 5 AAC 58.022. Waters; seasons; bag, possession, and size limits; and special provisions for Cook Inlet – Resurrection Bay Saltwater Area. (b)(1)(A) are superseded by this emergency order. Under this emergency order, the following provisions are effective, beginning 12:01 a.m., Saturday, June 15, 2013, through 11:59 p.m., Monday, July 15, 2013:

### 5 AAC 58.022. Waters; seasons; bag, possession, and size limits; and special provisions for Cook Inlet – Resurrection Bay Saltwater Area.

- (b)(1) in waters of Cook Inlet north of the latitude of Bluff Point (59° 40.00' N. lat.):
  - (A) south of the latitude of the mouth of the Ninilchik River ( $60^{\circ}$  03.99' N. lat.) to the latitude of Bluff Point ( $59^{\circ}$  40.00' N. lat.) and within one statute mile of shore, sport fishing for king salmon is closed; king salmon may not be retained or possessed; king salmon that are caught may not be removed from the water and must be released immediately;

### JUSTIFICATION:

King salmon stocks in Cook Inlet and throughout Alaska are experiencing a period of low productivity and low run strength. All indices of abundance suggest poor run strength trends for early-run king salmon stocks in lower and upper Kenai Peninsula streams. Sport fishing restrictions to inriver fisheries have been enacted on Deep Creek and the Anchor, Ninilchik, and Kasilof rivers, and early-run king salmon on the Kenai River in an effort to achieve adequate escapement into these streams. King salmon

of Cook Inlet origin generally have a higher probability of being harvested near shore than do king salmon from other locations. Mature king salmon (spawners) also tend to be harvested near shore at a greater rate than immature (non-local) king salmon. Therefore, it is justified to close fishing for king salmon in salt waters within one mile of shore while these locally spawning king salmon, and other stocks mentioned above, migrate through the area and into fresh water.

#### PREVIOUS EMERGENCY ORDERS AFFECTED:

Emergency Order No. 2-KS-7-04-13, that established a combined annual limit of two king salmon 20 inches or greater in length for fish harvested in the Anchor River, Deep Creek, Ninilchik River, and all marine waters south of the latitude of the mouth of the Ninilchik River to the latitude of Bluff Point from May 1, 2013 through June 30, 2013, is superseded.
