Effective Date: 12:01 a.m., Saturday, August 10, 2013 Expiration Date: 11:59 p.m., Tuesday, December 31, 2013, unless superseded by subsequent emergency order.

EXPLANATION:

This emergency order increases the bag and possession limit for coho salmon from 5 to 10 in all waters of the Nushagak-Mulchatna River drainage, excluding the Wood River drainage. The limit for other salmon, other than king salmon, remains at 5 per day, 5 in possession. These limits are in addition to the more liberal limits for coho salmon.

REGULATION:

The provisions of 5 AAC 67.022. Special provisions for seasons, bag, possession, and size limits, and methods and means in the Bristol Bay Area (g) (7) is added by this emergency order. Under this emergency order, the following provisions are effective beginning 12:01 a.m., Saturday, August 10, 2013, through 11:59 p.m., Tuesday, December 31, 2013:

5 AAC 67.022. Special provisions for seasons, bag, possession, and size limits, and methods and means in the Bristol Bay Area.

(g)(7) the limit for coho salmon is 10 per day, 10 in possession; the limit for other salmon, other than king salmon, is 5 per day, 5 in possession.

JUSTIFICATION:

The escapement of coho salmon in the Nushagak River has exceeded the escapement goal of 60,000 - 120,000 fish. Through August 8 over 129,000 coho salmon are estimated to have past the Portage Creek sonar. As provided by 5 AAC 75.003 EMERGENCY ORDER AUTHORITY (2) (A), the Department has emergency order authority to increase sport fish bag and possession limits when the total escapement is projected to exceed the escapement goal and the total harvest under the increased bag and possession limit will not reduce the escapement below the goal range. Therefore, it is warranted to increase the bag and possession limit for coho salmon in the Nushagak-Mulchatna River sport fishery.
