### **EXPLANATION:**

This emergency order increases the bag and possession limits for sockeye salmon from five to 10 fish in all waters of the Alagnak River drainage. The bag and possession limit for other salmon, except king, coho and sockeye salmon, remains at five fish. These limits are in combination with the more liberal limit for sockeye salmon.

### **REGULATION:**

The provisions of 5 AAC 67.022. (f)(2) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Wednesday, July 7 through 11:59 p.m. Friday, December 31, 2021:

#### **5 AAC 67.022. Special provisions for the seasons, bag, possession, and size limits, and methods and means in the Bristol Bay area.**

- (f) In the Alagnak River drainage, the following special provisions apply;
  - (2) the bag and possession limit for salmon, other than king salmon, is 10 fish with no size limit, of which only five fish, in combination may be chum and pink salmon, and three of which may be coho salmon;

### **JUSTIFICATION:**

The escapement of sockeye salmon in the Alagnak River has exceeded the escapement goal of 320,000 fish. Through July 5, 2021, a total of 605,000 sockeye salmon have been counted at the Alagnak River tower. As provided by 5 AAC 75.003. Emergency Order Authority (2)(A), the Department has emergency order authority to increase sport fish bag and possession limits when the total escapement is projected to exceed the escapement goal and the total harvest under the increased bag and possession limit will not reduce the escapement below the goal range. Therefore, it is warranted to increase the bag and possession limit for sockeye salmon in the Alagnak River sport fishery.
