EXPLANATION:

This emergency order reduces the bag and possession limit for northern pike in all lakes and flowing waters of the Minto Flats area to two fish, only one of which may be 30 inches or greater in length.

REGULATION:

Consistent with 5 AAC 74.044. Minto Flats Northern Pike Management Plan, the provisions of 5 AAC 74.010. (c)(2)(D) and (c)(27) are superseded by this emergency order. Under this emergency order, the following provisions are effective 12:01 a.m. Wednesday, June 1 through 11:59 p.m. Friday, October 14, 2022:

5 AAC 74.010. Seasons, bag, possession, and size limits, and methods and means in the Tanana River Area.

(c)(2) in the Chatanika River and its tributaries,

(D) northern pike may be taken only from June 1 through October 14, with a bag and possession limit of two fish, of which only one fish may be 30 inches or greater in length;

(c)(27) in the Tolovana River drainage, northern pike may be taken only from June 1 through October 14, with a bag and possession limit of two fish, of which only one fish may be 30 inches or greater in length;

JUSTIFICATION:

The *Minto Flats Northern Pike Management Plan* requires the sport fish bag and possession limit to be reduced to two fish, only one fish 30 inches or greater, in all lakes and flowing waters of the Minto Flats area (comprised of the Chatanika and Tolovana River drainages) if subsistence harvest reports indicate 750 or more northern pike are harvested from the Chatanika River drainage upstream of the confluence of the Chatanika and Goldstream Creek from January 1 until these waters are ice free.

Due to subsistence harvests exceeding 750 northern pike, the sport fish bag and possession limit must be reduced to comply with the provisions of the management plan.

Please read this Electronic Records and Signature Disclosure (ERSD). It concerns your rights regarding electronically undertaking, and the conditions under which you and the State of Alaska agree to electronically undertake, the transaction to which it relates (the "TRANSACTION").

Consent to Electronically Undertake the TRANSACTION

You can electronically undertake the TRANSACTION only if you confirm that you meet the following requirements by selecting the box next to "I agree to use electronic records and signature" (the "AGREE BOX"):

- 1. you can fully access and have read this ERSD;
- 2. you can fully access all of the information in the other TRANSACTION records;
- 3. you can retain all of the TRANSACTION records in a form that you will be able to fully access for later reference;
- 4. you consent to undertake the TRANSACTION electronically; and
- 5. you are authorized to undertake the TRANSACTION. (Please note that falsely undertaking the TRANSACTION may subject you to civil liabilities and penalties and/or to criminal penalties.)

If you cannot or are not willing to confirm each of these five things, do not select the AGREE BOX.

Withdrawing Consent

If you select the AGREE BOX, you can withdraw your consent to electronically undertake the TRANSACTION at any time before you complete the TRANSACTION: simply do not finalize it. The only consequence of withdrawing your consent is that you will not finalize the TRANSACTION.

If you select the AGREE BOX, your consent will apply only to this TRANSACTION. You must separately consent to electronically undertake any other transaction with the State of Alaska.

Paper Option for Undertaking the TRANSACTION

You may undertake the TRANSACTION with the State of Alaska using paper records. (State of Alaska employees who want to undertake the TRANSACTION in paper should contact the agency responsible for the TRANSACTION.) The State of Alaska will not provide a paper copy of the TRANSACTION records as part of the TRANSACTION. Under the Alaska Public Records Act (APRA), AS 40.25.100–.295, you can request a copy from the agency responsible for the TRANSACTION, but if too much time has passed, the agency may no longer have the records when you make your request. If required under the APRA, the agency will charge a fee.

These requirements may change. In addition, you need access to an email account.
