## LIST OF TABLES AND FIGURES

Note: all the information is for a 12-month study year from January 1 through December 31, 1994. It was collected in February 1995 during household interviews conducted by Craig Mishler and Amy Paige from the Division of Subsistence, ADF&G. They were assisted by Agafangel Lekanof of Saint George. The village council approved the project in advance of the interviewing.

Numbers represent estimated totals, meaning that they are expanded to the total community population based upon the information from the sample of households that were interviewed.

### Table 1. Sampling and Participation, Saint George and Saint Paul

This table summarizes the number of households surveyed. It also shows the number of households which declined to be interviewed and the number that researchers could not contact.

### Table 2. Demographic Characteristics of Households

This table reports various characteristics of the population of the community, including household size, age (in years), length of residency (in years), sex, and ethnicity.

### Table 3 and Figure 1. Population Profile by Age and Sex

This figure and table show the number and percent of the community population by age and sex.

### Table 4. Employment Characteristics

This table shows various features of cash employment in the community, such as number of jobs, the number and percentage of employed adults, and length of employment. Also shown are the number of jobs and employed adults per household.

### Table 5. Employment by Industry Category

This table shows the percentage of jobs held by community residents by the type of industry they are employed in. It also shows the percentage of individuals employed in these categories and the percentage of households with members employed in these categories. Categories are agriculture, forestry, & fishing (including commercial fishing and trapping); manufacturing (such as cannery work); federal government (such as the post office); state government; local government-noneducational (village council); local government-educational (school district); finance, insurance, and real estate (such as the village corporation); services (VPSO, health aides, etc.); transportation, communication, and utilities; mining; retail trade; and construction.

### Table 6. Community, Household, and Per Capita Incomes by Employer Types

This table gives the estimated monetary income from all sources (jobs and other sources of income) for the community overall, and the average per household and per person. Total income is given, as well as income by industry type.

Table 7. Community, Household, and Per Capita Other Income by Source

This table shows income from sources other than jobs, such as public assistance, pensions, and the Alaska Permanent Fund Dividend.

Table 8. Participation in the Harvesting and Processing of Wild Resources

This table shows the percentage of people in the community who hunted (for reindeer, marine mammals, or birds), fished (for salmon, other fish, or shellfish), trapped or hunted furbearers, or gathered wild plants in the study year. Also shown is the percentage of people who processed wild resources (butchered, skinned, split fish, put up berries, etc.)

Table 9. Resource Harvest and Use Characteristics

This table shows the percentage of households that used, tried to harvest, harvested, received, and gave away subsistence resources in the study year. It also shows the average number of different kinds of wild foods that were used by each household. Also shown is the estimated harvest of subsistence resources by the community and the average harvest per household and per person, in pounds usable weight.

Table 10. Estimated Harvest and Use of Fish, Land Mammals, Marine Mammals, Birds, and Plant Resources

This table gives detailed information about the harvest and use of specific resources (such as halibut, king crab, and fur seal), resource categories (such as salmon, non-salmon fish, land mammals), and all resources. It gives the percentage of households using, trying to harvest, harvesting, receiving, and giving away each resource. It also reports harvest quantities in usable pounds and in numbers of animals or other reporting units such as gallons (gal).

Table 11. Estimated Amount of Resources Removed from Commercial Harvests

This table reports the estimated amount of resources that households removed from their commercial harvests for their home use and for sharing. It does not include resources that were sold.

Table 12. Estimated Salmon Harvest by Gear Type

This table shows the number of total salmon and the number of salmon by species that were harvested for home use by various subsistence methods, by removing them from commercial catches, and by rod and reel. Also shown is the number of pounds harvested.

Table 13. Estimated Percentages of Salmon Harvest by Species, Gear Type, and Total Salmon Harvest

This table shows the percentage of total salmon and each salmon species that were harvested for home use by various subsistence methods, removing them from commercial catches, and by rod and reel. Percentages are calculated based upon usable pounds and based upon numbers of fish.

Table 14. Percentage of Households Harvesting Salmon by Gear Type and Species

This table shows the percentage of households that caught salmon for home use by using various subsistence methods, removing them from commercial catches, and by rod and reel.

Table 15. Estimated Harvest of Fish Other Than Salmon by Gear Type

This table shows the number of non-salmon fish (such as halibut), by total pounds and the number of pounds per species that were harvested for home use by subsistence gear, removing them from commercial catches, and by rod and reel.

Table 16. Estimated Percentages of Fish Other Than Salmon Harvested by Gear Type

This table shows the percentage of total non-salmon fish and the percentage of each species that were harvested for home use by subsistence gear, removing them from commercial catches, and by rod and reel.

Table 17. Percentage of Households Harvesting Fish Other Than Salmon by Gear Type

This table shows the percentage of households that caught non-salmon fish for home use by subsistence gear, removing them from commercial catches, and by rod and reel.


