July 21, 2021

This meeting of the Kuskokwim River Salmon Management Working Group was called to order at 10:03 a.m. and adjourned at approximately 11:30 a.m. A quorum was established with 7-9 full voting members present throughout the meeting. Mary Peltola (2nd Member at Large) chaired the meeting.

AGENDA ITEMS

A. USFWS/KRITFC UPDATE: Audio for this update begins at 14:50 – Meeting Audio – 07/14/21

 Boyd Bilhovde (USFWS) spoke about Tuesday's meeting with the KRITFC where there was a unanimous vote to relinquish the emergency special action for chinook conservation. This action turns management back over to the state for the remainder of the year.

A. ADF&G MANAGEMENT ACTIONS UNDER CONSIDERATION:

- Nick Smith (ADF&G) Reiterated last week's recommendation- that we follow a similar opening schedule as has been recently announced (Friday (7/23) drift/set, weekend (7/24-25) set) until the end of July, which would be where historically the chum salmon run was >95% through Bethel. At that time (7/31), he recommended that the lower river be opened 24/7 using similar gillnet restrictions as enacted in the past.
- **B. PEOPLE TO BE HEARD:** *None for this meeting.*
- C. CONTINUING BUSINESS: Audio for subsistence reports begins at 30:50 Meeting Audio 07/14/21
 - Subsistence Reports: Lowest River, ONC Inseason Subsistence Report, Lower River, Middle River, Upper River, Headwaters
 - Lowest River
 - Charlie Brown (Eek, Commercial Fishing) stated that the kings were through the lower river and that there was no real concern for them now.
 - ONC Inseason Subsistence Report:
 - No report given this meeting.
 - Lower River
 - Mary Peltola (Bethel; 2nd Member at Large) caught 206 salmon (3 were chums) during the past openings. She asked a question regarding the false pass, area M fisheries.
 - Albert Kawagely (Bethel; 1st Member at Large, alt.) set nets in the Gweek over the past week and caught some whitefish.
 - Mike Williams, Sr. (Akiak, Lower River Subsistence) said he was pretty much finished with fishing and wanted to get out and pick berries. He was pleased with the amount of red salmon returning this year but concerned for the chums.
 - John Andrew (Kwethluk; Downriver Elder / YK Delta RAC) said he did well on the previous openings. In a couple of hours he had caught a good amount of reds, a few chums, and a jack king.
 - o Middle River
 - Walter Morgan (Kalskag, Middle River Subsistence) people are pretty much finished fishing and have been happy with the run. People are now out looking for berries. When silvers show up people will want to go out after them.
 - o Upper River
 - Barbara Carlson (Sleetmute; Upriver Subsistence) has been operating the community fish wheel but turned it off last Friday. She estimated it was catching 50-60 reds a day, a few kings, and fewer chums. She said she would turn it back on soon for those that needed more fish.
 - Headwaters
 - Dan Esai (Nicolai; Headwaters) said that not much fishing was going on in Nicolai. People hoped to get about 10 kings per household and some sheefish.
 - Kevin Whitworth (McGrath, WIRAC) stated that people were fishing but not catching much.
