



Subject: Reflection Lake

Hi J,

In mid August 2004, as part of an ongoing field project to inventory fish passage in fish-bearing waters within the Municipality of Anchorage, we collected data describing culverts at the inlet to Reflection Lake and in the stream outlet of this lake that flows into the South Fork Chester Creek. Recently, because of a pending development project at the lake along with some beaver management issues, we were asked to verify fish distribution in the outlet stream and in Reflection Lake. We visited the site three times and observed or trapped anadromous fish in the lake and in the outlet stream. With the potential for further development near the inlet stream at Reflection Lake, we believe that it would be in the best interest of the fish resource in this area if our findings are included in the 2005 update of the Fish Distribution Database.
