
Comments:

On 5/27/10, I walked Bear Creek upstream from the mouth to document the upper extent of fish use. I captured several dozen rearing coho and sockeye along the way using a hand net, and found the upper extent of the creek at a headwater upwelling near a seasonal wetland area. Please add rearing coho and sockeye to the stream and reduce the upper extent of Bear Creek to the waypoint given above. The stream course downstream of the upper extent is correct.
