**Comments:** All fish captures were associated with an AKSSF funded research project (AWC Catalog Inventories in SEAK), which included stream habitat inventory, stream mapping, and identifying fish distribution patterns for updating the AWC and corporate hydrography databases. Fish capture methods employed baited and sterilized Gee Minnow Traps Minnow traps soaked for 1-6 hours or hand dip nets. All fish captured were identified to species and life stage noted, and released near the point of capture alive. Attachment pages/maps (see below) provide additional specific information regarding the presence of fish species, locations (latitude & longitude coordinates), number & species captured, and additional info.


