SUBJECT: Need to act on information request, and proposed stream de-classification

On behalf of Haines area landowner, John Floreske, Darrell Maple (October 3, 1995) requested the supporting documentation for classifying eight tributaries to Sawmill Creek in Haines which run through or adjacent to his properties.

Four of these streams run through Mr. Floreske's property south of Comstock Road and Mr. Maple has now requested that they be deleted from the Anadromous Fish Waters Catalog. The appropriate "nomination" forms have been filled out and signed by Mr. Maple and are attached. I have also signed the forms as Area Biologist, though I hereby state that I in no way support the de-classification of these streams. My signature is only intended to allow the administrative process to proceed.

I am sending these materials to you because a recent contact with our Anchorage office revealed that no one is currently assigned to provide the requested information or to process nominations to the Anadromous Fish Waters Catalog. Please advise how and when this information request and request to delete streams from the catalog will be handled so that I can inform Mr. Maple.

Re: Reclassifications of Streams

Dear John,

Thank you for sending me the appropriate application forms to request reclassification of several minor tributaries located upon Mr. Floreske's property. Although you indicated that #115-32-10300-2002-4001 has been cataloged, we do not have any evidence of this to date. Tributary #4017 was according to the last information received from your Division, referred to as "probably" having spawning habitat. We have filled out the forms and attached them via this fax for processing, to ensure time parameters are met. We still do not have the documentation that they indeed have been classified as anadromous streams. Please note that Mr. Floreske requested this information almost two years ago from your Anchorage office, whom does the classifications and to date no information was provided.

Please refer to our 10/03/95 correspondence to Mr. Frank Rue, which requests substantial information be provided the property owner on streams in this area. I do know that you are preparing a response, and sending us these forms ahead of time, was to assist us in making the deadline for submission of reclassification. The applicant whom is requesting the declassification is very much at a disadvantage if he does not have the public information on how the streams were classified in the first place, and the scientific data on which the classification is based.

I look forward to your visit at the end of the month wherein we can look at an overall solution which benefits both the property owner and the fisheries habitat upon the property in question.




Figure 1. Map of the area showing approximate stream locations and impact regions.

SUBJECT: Nomination to Delete Anadromous Waterbodies

I received a memo from John Palmes through you dated November 15, 1995. In the memo, you request that four streams which run through Mr. John Floreske's lands be deleted from the anadromous waters catalog.

I am remanding the request back to your office for action. Our procedure for reviewing nominations to delete waterbodies from the anadromous waters catalog is as follows:

1. Upon receipt of a nomination to delete a specified waterbody, an area biologist conducts a field review during an appropriate timing window to determine whether or not fish are present.
2. The area biologist files a report stating whether or not fish are present, and what obstacles to fish passage, if any, can be observed at the site in question. The biologist then forwards the field report to the Regional Supervisor.
3. The Regional Supervisor reviews the report and makes a finding. If fish are present, our statutes require us to deny the request and the party who nominated the streams is promptly notified of the denial.

4. If fish are not present, the Regional Supervisor determines whether or not: a) repeat sampling is warranted; and/or b) fish passage, if blocked, can be restored to the affected stream. For example, if fish passage was blocked by a cataclysmic event such as an earthquake or landslide, the Regional Supervisor would approve the request for reclassification and forward the regional approval to the Director's office. If blockage was due to a violation of an anadromous stream or other permit or regulatory action, the Regional Supervisor would deny the request and work towards remedial restoration for the stream at issue.

5. All Regional Supervisor approvals to delete *cataloged* streams will be reviewed by the Director's office before being forwarded to the Catalog section for final implementation.

4. If fish are not present, the Regional Supervisor determines whether or not: a) repeat sampling is warranted; and/or b) fish passage, if blocked, can be restored to the affected stream. For example, if fish passage was blocked by a cataclysmic event such as an earthquake or landslide, the Regional Supervisor would approve the request for reclassification and forward the regional approval to the Director's office. If blockage was due to a violation of an anadromous stream or other permit or regulatory action, the Regional Supervisor would deny the request and work towards remedial restoration for the stream at issue.
5. All Regional Supervisor approvals to reclassify ^{delete} *cataloged* streams will be reviewed by the Director's office before being forwarded to the Catalog section for final implementation.
