Comments: This nomination (11.53mp) is a tributary of the Yahtse River (10100). During our field trip in June we used a minnow trap to verify coho in this system. The trap was left soaking for 90 minutes and 16 juvenile coho were identified and released. The gradient at this location is extremely flat and this particular system flows through several lakes. It eventually flows out and into the Yahtse River. A GPS way point was taken at the furthest north position just about dead center of Section 5: N.59 52.361, W.141 11.093.


