EXPLANATION:

This emergency order increases the king salmon bag limit from one per day and two in possession to two per day and four in possession, and allows sport fishing to occur 24 hours per day in portions of those waters of the Deshka River drainage open to king salmon fishing, beginning 6:00 a.m., Friday, May 26, through 11:59 p.m., Thursday, July 13, 2006.

The area open to king salmon fishing in the Deshka River drainage is from the mouth of the Deshka River upstream to an ADF&G marker located near Chijuk Creek (river mile 17), and all waters within a one-half mile radius of the Deshka River's confluence with the Susitna River. That part of the Deshka River adjacent to the weir (300 ft. upstream and downstream of the weir located at river mile 7) remains closed to fishing as noted by department regulatory markers.

The annual limit and harvest record requirement remains in effect.

REGULATION:

The provisions of 5 AAC 61.022. WATERS; SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE SUSITNA – WEST COOK INLET AREA. (d)(6)(B) are superseded by this emergency order. Under this emergency order, the following provisions are effective, beginning 6:00 a.m., Friday, May 26, through 11:59 p.m., Thursday, July 13, 2006:

5AAC 61.022. WATERS; SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE SUSITNA – WEST COOK INLET AREA.

(d)(6) in the Deshka River drainage, including Trapper Lake,

(B) from its mouth upstream to ADF&G regulatory markers near Chijuk Creek (river mile 17), and in all waters within a one-half mile radius of its confluence with the Susitna River, king salmon 20 inches or greater in length may be taken January 1 - July 13; from September 1 – May 14, only unbaited, artificial lures may be used; from May 15 – August 31, bait may be used; the remainder of the drainage is closed from January 1 – December 31 to sport fishing for king salmon; bag limit is two fish per day, and four in possession; sport fishing for any finfish species is open 24-hours per day;

JUSTIFICATION:

King salmon returns to the Deshka River have been above the upper range of the biological escapement goal (BEG) for the past seven years. It is anticipated that the 2006 king salmon return will be well above the upper end of the BEG as well, thus creating a surplus of king salmon needed for spawning. The average Deshka River king salmon sport harvest is approximately 7,400 fish annually. By increasing bag and possession limits and extending fishing hours, an additional 3,000 to 5,000 fish will likely be harvested. The anticipated escapement from this increased harvest will still be near or over the upper range of the BEG.
