Expiration Date: 11:59 p.m., Friday, July 14, 2006, unless superseded by subsequent emergency order.

EXPLANATION:

This emergency order prohibits the filleting, heading, mutilation or disfigurement of king salmon in such a manner that would prevent the determination of the overall length of king salmon until the fish is brought to shore and offloaded from a vessel or removed from a shoreline fishing location in the fresh waters of the Kenai River that are open to king salmon fishing. This emergency order is effective from 12:01 a.m., Monday, May 1, 2006, through 11:59 p.m., Friday, July 14, 2006.

REGULATION:

The provisions of 5 AAC 56.023. SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE KENAI RIVER DRAINAGE. (a)(1)(A)(v) are added by this emergency order. Under this emergency order the following provisions are effective from 12:01 a.m., Monday, May 1, 2006, through 11:59 p.m., Friday, July 14, 2006:

5 AAC 56.023. SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE KENAI RIVER DRAINAGE.

(a)(1)(A)(v) a person may not possess a king salmon that has been filleted, headed, mutilated, or otherwise disfigured in a manner that prevents determination of the length of fish taken until the fish is permanently offloaded from a vessel if the fish was taken from a vessel or permanently transported away from the fishing site if the fish was taken from the riverbank; for the purposes of this subparagraph, "fishing site" means the riverbank where the fish was hooked and removed from the water becoming part of the angler's bag limit;
