EXPLANATION:

This emergency order opens the Russian River Sanctuary Area to fishing for sockeye salmon at 6:00 a.m., Wednesday, June 21, 2006. The sockeye salmon bag and possession limit is three (3) fish.

REGULATION:

The provisions of 5 AAC 56.023 WATERS; SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE KENAI RIVER DRAINAGE. (d)(1)(E) are superseded by this emergency order. Under this emergency order, the following provisions are effective:

5 AAC 56.023. WATERS; SEASONS; BAG, POSSESSION, AND SIZE LIMITS; AND SPECIAL PROVISIONS FOR THE KENAI RIVER DRAINAGE.

(d)(1)(E) The Russian River Sanctuary, including waters upstream from ADF&G regulatory markers located just downstream of the ferry crossing on the Kenai River to ADF&G regulatory markers located approximately 300 yards upstream of the public boat launch at Sportsman's Landing (including the waters around the upstream end of the island near the Russian River mouth) and the Russian River from its mouth upstream 100 yards to ADF&G regulatory markers, is open to fishing from 6:00 a.m., Wednesday, June 21, 2006, through 11:59 p.m., Friday, July 14, 2006.

JUSTIFICATION:

Department staff have determined that the early run sockeye spawning escapement goal of 14,000-37,000 fish at the Lower Russian Lake weir will be achieved. As of June 20, more than 9,000 sockeye salmon have been counted at the Russian River weir. Department staff estimates that 5,000-6,000 sockeye salmon are present in the Russian River Sanctuary, with further indications of sockeye salmon observed in the Russian River from the Russian River falls extending downstream to the closed fishing

boundary above the recreational fishery of approximately 10,000 fish. Based upon these observations, it is appropriate to liberalize the fishery by permitting anglers the opportunity to harvest sockeye salmon in the Russian River Sanctuary Area.
