Expiration Date: 11:59 p.m. Sunday, July 8, 2007, unless superseded by subsequent emergency order.

### **EXPLANATION:**

This emergency order allows snagging in the waters of Kachemak Bay near the Nick Dudiak Fishing Lagoon, from the Homer City Dock near the entrance to the Homer Boat Harbor, northwest along the east side of the Homer Spit to the Department marker placed approximately 200 yards northwest of the entrance to the Nick Dudiak Fishing Lagoon on the Homer Spit, to a distance of 300 feet from the shore.

Snagging will be permitted only from 12:00 noon, Thursday, July 5, 2007, through 11:59 p.m. Sunday, July 8.

### **REGULATION:**

The provisions of 5 AAC 58.030 METHODS, MEANS, AND GENERAL PROVISIONS – FINFISH. (d) are superceded by this emergency order. Under this emergency order, the following provisions are effective beginning 12:00 noon, Thursday, July 5, 2007, through 11:59 p.m. Sunday, July 8, 2007:

#### **5 AAC 58.030 METHODS, MEANS, AND GENERAL PROVISIONS - FINFISH.**

d) From the Homer City Dock near the entrance to the Homer Boat Harbor, northwest along the east side of the Homer Spit to the Department marker placed approximately 200 yards northwest of the entrance to the Nick Dudiak Fishing Lagoon on the Homer Spit, to a distance of 300 feet from the shore, snagging is permitted only from 12:00 noon, Thursday, July 5, through 11:59 p.m., Sunday, July 8, 2007.

### **JUSTIFICATION:**

In 1988, the Alaska Board of Fisheries adopted a regulation whereby snagging would be permitted on and adjacent to the Homer Spit only after June 23 and only by Emergency Order. The Department would issue an Emergency Order only if there were stocked salmon in the Nick Dudiak Fishing Lagoon that could not be adequately harvested without snagging. These criteria have been met in that there are king salmon available that will not be adequately harvested unless angler efficiency is increased. This Emergency Order therefore permits snagging on and adjacent to the Homer Spit.
