2019 CARROLL INLET TERMINAL HARVEST AREA FISHERY ANNOUNCEMENT

Ketchikan. . . The Alaska Department of Fish and Game announced today the following information for the Southern Southeast Regional Aquaculture Association (SSRAA) concerning the Carroll Inlet Terminal Harvest Area (THA) for 2019.

The Carroll Inlet THA consists of those waters of Carroll Inlet north of Nigelius Point at 55°33.50' N. latitude.

Troll:

Salmon may be taken in the Carroll Inlet THA by troll gear from 12:01 a.m., Saturday, June 1, through 11:59 p.m., Sunday, June 30.

Net Fisheries:

Salmon may be taken in the Carroll Inlet THA by drift gillnet and purse seine gear concurrently from 12:01 a.m., Saturday, June 1, through 12:00 noon, Wednesday, June 12.

From 12:00 noon, Thursday, June 13, through 12:00 noon, Sunday, June 30, salmon may be taken in the Carroll Inlet THA by drift gillnet and purse seine gear as follows:

Drift Gillnet:

12:00 noon, Saturday, June 15, to 12:00 noon, Sunday, June 16;
12:00 noon, Wednesday, June 19, to 12:00 noon, Thursday, June 20;
12:00 noon, Sunday, June 23, to 12:00 noon, Monday, June 24;
12:00 noon, Thursday, June 27, to 12:00 noon, Friday, June 28;

Purse Seine:

12:00 noon, Thursday, June 13, to 12:00 noon, Friday, June 14;
12:00 noon, Monday, June 17, to 12:00 noon, Tuesday, June 18;
12:00 noon, Friday, June 21, to 12:00 noon, Saturday, June 22;
12:00 noon, Tuesday, June 25, to 12:00 noon, Wednesday, June 26;
