**NORTHERN SOUTHEAST OUTSIDE (NSEO) SECTION DIRECTED LINGCOD
FISHERY CLOSURE ANNOUNCEMENT**

Sitka... The Alaska Department of Fish and Game (ADF&G) announced today the directed fishery for lingcod will close in the entire Northern Southeast Outside (NSEO) Section at 1:00 pm, Monday, June 15, 2020. The 2020 directed lingcod fishery guideline harvest level (GHL) for the NSEO area is 17,200 round pounds. Based on reports from the grounds and harvest data to date, the department anticipates that the GHL will be taken by the time of the closure.

The directed lingcod fishery remains open in the Icy Bay Subdistrict (IBS), Central Southeast Outside (CSEO) Section, and Southern Southeast Outer Coast (SSEOC) Sector. Lingcod catches will be closely monitored and fishermen should expect additional area closures on short notice. Closure notices will be announced by ADF&G advisory announcement, United States Coast Guard "Notice to Mariners" report, and the National Weather Service marine broadcast.
