KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #11 For Emergency Order #4-FS-K-11-20

There will be an **81-hour** commercial salmon fishing period from **noon Monday, July 27 to 9:00 p.m. Thursday, July 30** in the following areas:

- The **Sturgeon, Inner Karluk and Outer Karluk** sections of the **Southwest Kodiak District**;
- The **Northwest Kodiak District** (except the Anton Larsen Bay, Sharatin Bay, Kizhuyak Bay, Zachar Bay, Spiridon Bay, and Uyak Bay sections will remain closed); and
- The **Southwest Afognak, Inner Kitoi Bay, Outer Kitoi Bay, Izhut Bay, and Duck Bay** sections of the **Afognak District**.

Closed Water Adjustments:

Closed waters will be and **increased** from **noon Monday, July 27 to 9:00 p.m. Thursday, July 30** to the ADF&G markers placed by hatchery staff near **Big Kitoi Creek** (stream #252-324), and to the ADF&G markers at **Little Kitoi Creek** (stream #252-323).

Closed waters will be **reduced** from **noon Monday, July 27 to 9:00 p.m. Thursday, July 30** in the following areas:

- To **Karluk Lagoon's** exit channel terminus at the ocean shoreline (stream #255-101);
- To **Sturgeon Lagoon's** exit channel terminus at the ocean shoreline (stream #256-401).

There will be a **57-hour** commercial salmon fishing period from **noon Monday, July 27 to 9:00 p.m. Wednesday, July 29** in the following areas:

- The **Outer Ayakulik and Halibut Bay** sections of the **Southwest Kodiak District**;
- The **Cape Alitak, Humpy-Deadman, Alitak Bay, Moser Bay, and Olga Bay** sections of the **Alitak District**;
- The **Big River, Hallo Bay, Outer Kukak Bay, Dakavak Bay and Katmai** sections of the **Mainland District**;
- The **Alinchak Bay Section** of the **Mainland District** north of the latitude of **Cape Kekernoi** (57° 43.50' N lat.).

Closed Water Adjustments:

Closed waters will be and **increased** from **noon Monday, July 27 to 9:00 p.m. Wednesday, July 29** in **Deadman Bay**, of the **Humpy-Deadman Section** of the **Alitak District** to all the waters of Deadman Bay, north of a latitude of **Cape Hepburn** (56° 57.5 N. lat.).

The **Seaward Zones** of the **Alinchak Bay, Katmai, Dakavak Bay, Outer Kukak Bay, Hallo Bay, and Big River sections** of the **Mainland District** remain **closed** to commercial salmon fishing.

As Previously Announced:

The following area remains **open until further notice:**

- The **Spiridon Bay Special Harvest Area (Telrod Cove).**

Until further notice, in that portion of the **Northwest Kodiak and Southwest Kodiak districts south of the latitude of Cape Kuliuk**, **Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear** in the commercial salmon fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office. Recent salmon fishery information may be obtained by calling the Department's 24-hour record-a-phone at 486-4559.
