### **UPPER COOK INLET COMMERCIAL FISHING ANNOUNCEMENT No. 25 EMERGENCY ORDER NUMBER 2S-25-20**

Upper Cook Inlet (UCI) Commercial Fishing Announcement No. 25 opens commercial fishing with drift gillnets in the Expanded Kenai and Expanded Kasilof sections of the Upper Subdistrict and the Anchor Point Section of the Lower Subdistrict from 7:00 a.m. until 7:00 p.m. on Monday, August 3, 2020. Commercial salmon fishing with drift gillnet gear remains closed within one mile of the Kenai Peninsula shoreline north of the Kenai River and within one and one-half miles of the Kenai Peninsula shoreline south of the Kenai River.

All other set gillnet fisheries in UCI will fish the regularly scheduled period from 7:00 a.m. until 7:00 p.m. on Monday, August 3, 2020, except in that portion of the Western Subdistrict of the Central District south of the latitude of Redoubt Point, which is open from 6:00 a.m. until 10:00 p.m. on Monday August 3, 2020.

As of August 1, the Kasilof River sockeye salmon run is 88% complete based on average run timing and projects a final escapement of more than 450,000 fish. The biological escapement goal for Kasilof River sockeye salmon of 140,000 to 320,000, and the optimal escapement goal of 140,000 to 370,000 have been exceeded. In the Kenai River, average sockeye salmon passage into the Kenai River is 70% complete through August 1, projecting an inriver run of 1.0 to 1.1 million sockeye salmon based on average to 3 day late run timings. Additionally, current coho salmon escapement to the Little Susitna River projects well below the sustainable escapement goal range of 9,000 to 17,700. Therefore, in order to harvest Kenai and Kasilof river salmon, while minimizing harvest of Northern Cook Inlet coho salmon, the drift gillnet fishing period on Monday, August 3, 2020 is being restricted to the Expanded Kenai, the Expanded Kasilof and the Anchor Point sections.

As a reminder, UCI Commercial Fishing Announcement No. 24 modified and continued gear reductions in the Northern District set gillnet fishery of Upper Cook Inlet. Legal gear in the General Subdistrict of the Northern District south of the Susitna River, and in the Eastern Subdistrict of the Northern District is limited to no more than two set gillnets per permit, each not exceeding 35 fathoms in length, and with the aggregate length not to exceed 70 fathoms, from 7:00 a.m. until 7:00 p.m. on Monday, August 3, 2020, and from 7:00 a.m. until 7:00 p.m. on Thursday, August 6,

2020. Legal gear in the General Subdistrict of the Northern District east of the Susitna River, which includes Fire Island, will be limited to no more than one set gillnet per permit, measuring no more than 35 fathoms in length, from 7:00 a.m. until 7:00 p.m. on Monday, August 3, 2020, and from 7:00 a.m. until 7:00 p.m. on Thursday, August 6, 2020.
