## COMMERCIAL SALMON FISHING TO REOPEN IN NOME, GOLOVIN AND ELIM

Commercial salmon fishing will be open for 24 hours in Subdistricts 1, 2, and 3 the Nome, Golovin and Elim Subdistricts beginning Friday evening, September 4. Permit holders are limited to 100 fathoms of gillnet in aggregate length and gillnets must have a mesh size of 6 inches or smaller. Golovin and Elim Subdistricts will be open to commercial salmon fishing from 6 p.m. Friday until 6 p.m. Saturday and Nome Subdistrict will be open to commercial salmon fishing from 9 p.m. Friday until 9 p.m. Saturday.

During the recent opening ending Thursday night permit holders were affected by wind and high seas but catches were above average in Nome and average in Elim. No permit holders fished in Golovin.

The weather forecast is for light winds until early Sunday and this short window of favorable conditions will allow a 24-hour commercial salmon fishing period.

Historically the escapement at the Kwiniuk, Shaktoolik and North River counting towers is well past the thirdquarter point of the silver run and at the Nome and Snake River weirs the escapement is just past the midpoint of the silver run.

Subsistence fishermen have recently reported good catches of bright silvers in both southern and northern Norton Sound.

After the upcoming commercial fishing period no more commercial salmon fishing is expected and the season will close by regulation after September 7.

The cumulative escapement counts are:

North River: 1,900 silvers Shaktoolik River: 3,900 silvers Kwiniuk River: 5,200 silvers Nome River: 1,300 silvers Snake River: 1,000 silvers
