## 2021 Kodiak Area State-Waters Pacific Cod Season Opening for Pot Gear

### **Emergency Order 4-GF-03-21**

The Kodiak Area state-waters Pacific cod pot gear season will open at 12:00 noon January 29, 2021. The 2021 Kodiak Area state-waters Pacific cod guideline harvest level (GHL) is 3.76 million pounds. Pot vessels are allocated 50% of the GHL or 1.88 million pounds. Vessels greater than 58 feet overall length are limited to 25% of the total GHL (941,000 pounds) while gear allocations are in effect.

Vessel operators must obtain a miscellaneous finfish pot gear interim-use permit card from the Commercial Fisheries Entry Commission and an exclusive state-waters vessel registration from the Alaska Department of Fish and Game (ADF&G) prior to participating in the state-waters fishery.

Pot vessels may not operate more than 60 groundfish pots and buoy tags are required for all pot gear. Vessel operators may store open and unbaited groundfish pots at any depth during the seven days between the closure of the CGOA parallel pot gear season and the start of the Kodiak Area state-waters pot gear season. Once the state-waters season opens, only 60 groundfish pots with buoy tags attached may be fished. Untagged pots in excess of the 60-pot limit may be stored in waters less than 25 fathoms in depth or be on board the vessel for up to seven days after the state-waters season opening. After seven days, only 60 tagged groundfish pots may be in the water or on board a vessel participating in the state-waters fishery.

Due to health concerns related to COVID-19 and to minimize contact between vessel operators, processor staff, and ADF&G staff, the vessel registration process has been streamlined and can be completed remotely. Vessel operators are encouraged to register by contacting the Kodiak ADF&G office by phone, mail, email, or fax. Buoy tags for pot gear vessels will be provided free of charge and can be mailed directly to vessel operators upon request. Vessel registration and buoy tags are also available at the ADF&G office in Kodiak.

Tender vessel operators must obtain a tender vessel registration for the state-waters Pacific cod fisheries and must use the tLandings electronic reporting application to report all groundfish delivered to a tender vessel.
