NORTHERN SOUTHEAST INSIDE (NSEI) AND SOUTHERN SOUTHEAST INSIDE (SSEI) SUBDISTRICTS SABLEFISH INDUSTRY MEETING

The Alaska Department of Fish and Game (ADF&G) will host an online meeting to review and discuss the status of NSEI and SSEI sablefish stocks with Southeast Alaska sablefish stakeholders and interested members of the public on **Friday, April 30, 2021, from 1:00 p.m. to 4:00 p.m.** via Zoom, due to COVID-19 pandemic considerations.

Topics will include:

- NSEI Chatham Strait and SSEI Clarence Strait
 - Survey, fishery, and data review updates
 - Outlook for sablefish quota
- Board of Fisheries update
- Gulf of Alaska Federal sablefish fishery information
