2021 Yukon River Salmon Summer Fishery Announcement #3 District 3 and Innoko River Subsistence Fishing Schedule

Districts Affected: Lower Yukon Area

The 2021 Chinook salmon run size is forecasted to be smaller than the 2020 run and may not be strong enough to meet escapement objectives. When run forecasts are this weak, regulations require that salmon fishing be closed on the first pulse. In accordance with the preseason management strategy to take a conservative approach this season, subsistence fishing will be closed during the trickle and first pulse of the Chinook salmon run. This is intended to protect Chinook salmon while more information about the timing and strength of the run is collected. The first Chinook salmon have been caught in the lower river test fisheries, and salmon fishing closures began in the Coastal District and District 1 on June 2, and in District 2 on June 4. Closures in each subsequent district are based on average swim speeds.

Due to the conservation concern for Chinook salmon, 4-inch or smaller mesh gillnets will be restricted to a maximum length of 60-feet effective when salmon fishing closures begin. Fishermen are reminded to set this gear in areas where non-salmon species are abundant to avoid incidentally harvesting Chinook salmon. While any salmon caught in 4-inch or smaller mesh gillnets may be kept, if it appears salmon are being targeted with this gear, it could be further restricted.

Subsistence Management Actions

District 3 (including Russian Mission and Holy Cross):

Subsistence fishing is currently open 24 hours a day, seven days per week with 7.5-inch or smaller mesh gillnets.

Effective 8 p.m. Monday, June 7, salmon fishing is closed. Gillnets larger than 4-inch mesh are not allowed. Gillnets of 4-inch or smaller mesh may be used to target non-salmon but are restricted to 60 feet maximum length.

Innoko River (including Shageluk):

Subsistence fishing is currently open 24 hours a day, seven days per week with 7.5-inch or smaller mesh gillnets.

Effective 8 p.m. Wednesday, June 9, salmon fishing is closed. Gillnets larger than 4-inch mesh are not allowed. Gillnets of 4-inch or smaller mesh may be used to target non-salmon but are restricted to 60 feet maximum length.

During subsistence salmon fishing closures, fishermen <u>may target non-salmon</u> with gears such as hook and line and dip nets. However, all chum salmon and Chinook salmon must be released from these gears.

The Emmonak office will be open to the public Mondays to Fridays 8 am to 5 pm, and Saturdays 1 pm to 5 pm. Closed on Sundays. ADF&G Emmonak office: (907) 949-1320.
