Bristol Bay Eastside Salmon Announcement #28 **Emergency Order 40 & 41**

This is the Alaska Department of Fish & Game in King Salmon with an announcement for permit holders in the Egegik and Ugashik districts. The time is 12:00 noon and the date is Tuesday, July 6, 2021.

Egegik District

Escapement through the Egegik River tower on July 5 was 69,000 fish for a cumulative of 933,000. Harvest from July 5 was 253,000 for a season total of 3.6 million fish. Currently, 292 vessels are registered to fish in the district.

Egegik District will open to commercial fishing with set gillnet gear for 8 hours from 9:30 p.m. Tuesday, July 6 until 5:30 a.m. Wednesday, July 7 and again for 8 hours from 9:15 a.m. until 5:15 p.m. Wednesday, July 7. Commercial fishing with drift gillnet gear will open for 5.5 hours from 9:45 p.m. Tuesday, July 6 until 3:15 a.m. Wednesday, July 7 and again for 6 hours from 9:30 a.m. until 3:30 p.m. Wednesday, July 7.

Ugashik District

Escapement through the Ugashik River tower on July 5 was 3,000 fish for a cumulative of 33,000. Harvest from July 5 was 126,000 for a season total of 669,000 fish. Currently, 102 vessels are registered to fish in the district.

Ugashik District will open to commercial fishing with set gillnet gear for 10 hours from 7:45 a.m. until 5:45 p.m. Wednesday, July 7. Commercial fishing with drift gillnet gear will open for 3.5 hours from 9:15 a.m. until 12:45 p.m. Wednesday, July 7.
