KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #33 For Emergency Order #4-FS-K-33-21

There will be a **24-hour extension** to the current commercial salmon fishing period from **9:00 p.m. Friday, August 13** until **9:00 p.m. Saturday August 14** in the following areas:

- The **Raspberry Strait, Northwest Afognak, Perenosa Bay, Northeast Afognak, Duck Bay, and Southeast Afognak Sections** of the **Afognak District**.
- The **Northeast Kodiak District** (except the Buskin River Section will remain closed);
- The **Inner and Outer Ugak Bay Sections** of the **Eastside Kodiak District**; and
- The **Mainland District** (except the Inner Kukak Bay Section will remain closed).

Closed Water Adjustment:

Closed waters are **reduced** from **noon Saturday, August 14 until further notice** at **Humpy Cove, to the stream terminus of Humpy Creek** (stream #257-701), and stream #257-703.

As previously Announced:

There will be a **57-hour** commercial salmon fishing period from **noon Friday, August 13** to **9:00 p.m. Sunday, August 15** in the **Outer Kitoi Bay Section** of the **Afognak District**.

The **Izhut Bay Section of the Afognak District south of a line from Haystack Rock** (at 58° 10.58' N lat., 152° 17.36' W long.) to **Pillar Cape** (at 58° 08.90' N lat., 152° 06.77' W long.) will **open** to commercial salmon fishing at **noon Friday, August 13** and remain **open until further notice**.

The current commercial salmon fishing period in the **Izhut Bay Section of the Afognak District north of a line from Haystack Rock** (at 58° 10.58' N lat., 152° 17.36' W long.) to **Pillar Cape** (at 58° 08.90' N lat., 152° 06.77' W long.) will be **extended** to **remain open until notice**.

The following areas are currently scheduled to **close** at **9:00 p.m. Sunday, August 15:**

- The **Northwest Kodiak District**;
- The **Southwest Afognak Section of the Afognak District**;
- The **Outer Ayakulik Section of the Southwest Kodiak District**;
- The **Cape Alitak, Humpy Deadman, Alitak Bay, Moser Bay, and Olga Bay Sections of the Alitak District**; and,
- The **Sitkalidak, Two-Headed, and Seven Rivers Sections of the Eastside Kodiak District**.

The **Spiridon Bay Special Harvest Area** (Telrod Cove) remains **open** to commercial salmon fishing **until further notice**:

Cost recovery fisheries began in the Kitoi Bay Special Harvest Area (SHA) on August 8. Fishing opportunities in the Duck Bay, Izhut Bay, Inner Kitoi Bay, and Outer Kitoi Bay sections will be dependent on the ability to meet KRAA cost recovery needs, and all cost recovery information can be obtained by calling 486-6559.

Until further notice, in that portion of the **Northwest Kodiak** and **Southwest Kodiak districts** south of the latitude of **Cape Kuliuk**, **Chinook (king) salmon 28 inches or greater in length** may not be retained by purse seine gear in the commercial fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office.
