Prince William Sound Salmon Fishery Announcement #73

SEINE FISHERIES: This announcement provides time and area specifics for a broad area commercial purse seine fishing opportunity on Monday, August 23.

Preliminary harvest estimates from fishing periods occurring on August 21 are as follows:

- Eastern District: 34,429 pink salmon with 5 reported deliveries.
- Northern District: 370,173 pink salmon with 40 reported deliveries.
- Coghill District: 272,902 pink salmon with 74 deliveries reported.
- Southwestern District: 260,646 pink salmon with 35 deliveries reported.
- Montague District: 391,827 pink salmon with 49 deliveries reported.

Aerial surveys of the Southwestern, Montague, and Southeastern Districts are being flown today.

Unless otherwise specified all regulatory closed waters and anadromous stream closures are in effect.

EASTERN DISTRICT: Waters of the Eastern District, south of a line from Potato Point to Entrance Point, will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Monday, August 23. **To support everyday fishing in the Eastern District, the Port Fidalgo SHTF marker will be used to protect late season wild chum salmon run entry.**

Waters inside the following Eastern District Salmon Harvest Task Force (SHTF) marker will be closed for this period to ensure late season escapement:

(1) Port Fidalgo Subdistrict: waters east of 146°24.12' W. long.

<u>NORTHERN DISTRICT:</u> Waters of the Northern District, excluding waters of the Cannery Creek Subdistrict north of the latitude of 60° 53.90' N and CCH SHA and THA, will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, Monday, August 23.


<u>COGHILL DISTRICT:</u> Waters of the Coghill District, excluding waters of the WNH SHA, will open to commercial purse seine and drift gillnet fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Monday, August 23. Regulatory closed waters and anadromous stream closures within the Granite Bay Subdistrict will not be in effect for this period.

NORTHWESTERN DISTRICT: Waters of the Northwestern District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, Monday, August 23.

MONTAGUE DISTRICT: Waters of the Montague District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Monday, August 23.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Monday, August 23.

SOUTHWESTERN DISTRICT: Waters of the Southwestern District, south of the latitude of 60° 11.50' N and east of Point Helen (147° 46.27' W.), **excluding waters of the San Juan Subdistrict and waters of the AFK THA and SHA**, will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Monday, August 23.



In response to COVID-19, all PWSAC facilities are closed to the public until further notice.

Copies of the updated regulation booklet, 2019-2021 Commercial Salmon Fishing Regulations for Prince William Sound, are available in the Cordova ADFG office.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
