### Prince William Sound Salmon Fishery Announcement #75

**SEINE FISHERIES:** This announcement provides time and area specifics for multiple broad area commercial purse seine fishing opportunities on Tuesday (8/24), Wednesday (8/25), and Thursday (8/26). **Please be advised that, dependent on future evaluations of broodstock needs, area in hatchery subdistricts may be adjusted via an unscheduled announcement.**

Preliminary harvest estimates from fishing periods occurring on August 22 are as follows:

- Eastern District: 73,431 pink salmon with 13 reported deliveries.
- Northern District: 179,140 pink salmon with 33 reported deliveries.
- Coghill District: 187,493 pink salmon with 43 deliveries reported.
- Southwestern District: 289,647 pink salmon with 40 deliveries reported.
- Montague District: 220,295 pink salmon with 39 deliveries reported.

**Unless otherwise specified all regulatory closed waters and anadromous stream closures are in effect.**

**EASTERN DISTRICT:** Waters of the Eastern District, south of a line from Potato Point to Entrance Point, will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26.

**Waters inside the following Eastern District Salmon Harvest Task Force (SHTF) marker will be closed for this period to ensure late season wild chum salmon escapement:**

- (1) **Port Fidalgo Subdistrict:** waters east of 146°24.12' W. long.

**NORTHERN DISTRICT:** Waters of the Northern District, **excluding waters of the Cannery Creek Subdistrict north of the latitude of 60° 53.90' N. and CCH THA and SHA**, will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26.

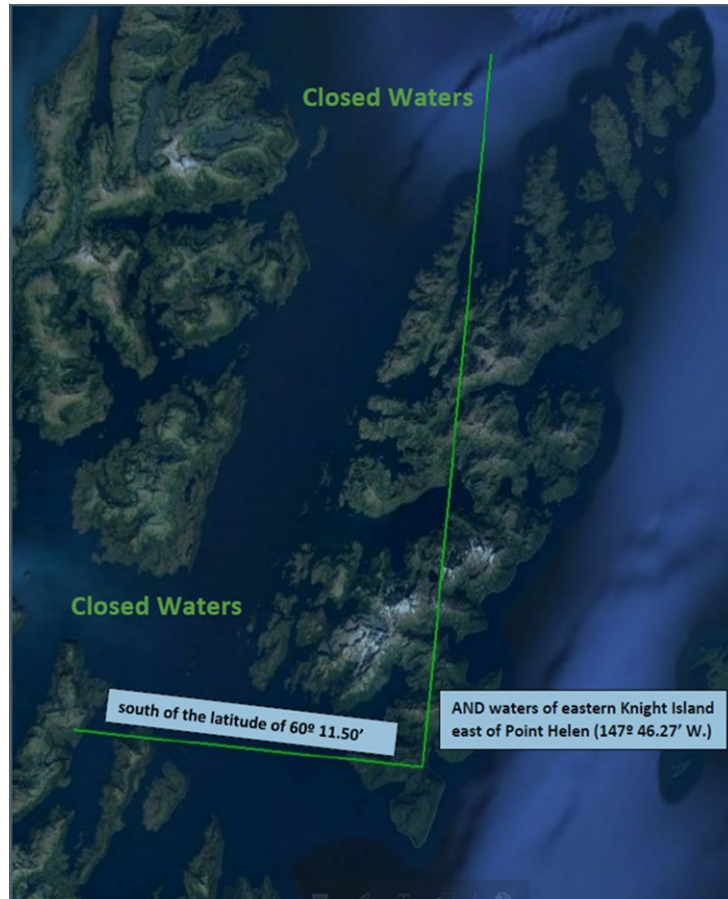
**COGHILL DISTRICT:** Waters of the Coghill District, **excluding waters of the WNH SHA and THA**, will open to commercial purse seine and drift gillnet fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26. Regulatory closed waters and anadromous stream closures within the Granite Bay Subdistrict will not be in effect for this period.

**NORTHWESTERN DISTRICT:** Waters of the Northwestern District will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26.

**MONTAGUE DISTRICT:** Waters of the Montague District will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26.

**SOUTHEASTERN DISTRICT:** Waters of the Southeastern District will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26.

**SOUTHWESTERN DISTRICT:** Waters of the Southwestern District, south of the latitude of 60° 11.50' N and east of Point Helen (147° 46.27' W.), **excluding waters of the San Juan Subdistrict and waters of the AFK THA and SHA**, will open to commercial purse seine fishing for three 12-hour periods, from 8:00 am until 8:00 pm, on Tuesday, August 24, Wednesday August 25, and Thursday August 26. **Anadromous stream closures within the Port Elrington Subdistrict will not be in effect during this fishing period.**

The next scheduled gillnet fisheries announcement is anticipated to be at 2:00 p.m. Wednesday, August 25.**

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.  
The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
