KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #40 For Emergency Order #4-FS-K-40-21

There will be a **72-hour extension** to the current commercial salmon fishing period from **6:00 p.m. Tuesday, August 24** until **6:00 p.m. Friday, August 27** in the following areas:

- The **Northwest Kodiak District**;
- The **Southwest Afognak Section** of the **Afognak District**;
- The **Outer Ayakulik Section** of the **Southwest Kodiak District**;
- The **Cape Alitak, Humpy-Deadman, Alitak Bay, Moser Bay, and Olga Bay Sections** of the **Alitak District**;
- The **Sitkalidak, Two-Headed, and Seven Rivers Sections** of the **Eastside Kodiak District**; and
- The **Northeast Kodiak District**.

There will be a **54-hour** commercial salmon fishing period from **noon Wednesday, August 25** until **6:00 p.m. Friday, August 27** in the following areas:

- The **Alinchak Bay, Cape Igvak, and Wide Bay Sections** of the **Mainland District**.

The current commercial salmon fishing period in the **Duck Bay Section** of the **Afognak District** will **close** at **6:00 p.m. Tuesday, August 24** and **reopen** for **30-hours** from **noon Thursday, August 26** until **6:00 p.m. Friday, August 27**.

The current commercial salmon fishing period in the **Inner Ugak Bay and Outer Ugak Bay Sections** of the **Eastside Kodiak District** will **close** at **6:00 p.m. Tuesday, August 24**.

As previously Announced:

Closed Water Adjustment:

Closed waters are **reduced until further notice** at **Humpy Cove, to the stream terminus of Humpy Creek** (stream #257-701), and stream #257-703.

Cost recovery fisheries have begun in the Kitoi Bay Special Harvest Area (SHA). Fishing opportunities in the Duck Bay, Izhut Bay, Inner Kitoi Bay, and Outer Kitoi Bay sections will be dependent on the ability to meet KRAA cost recovery needs, and all cost recovery information can be obtained by calling 486-6559.

Until further notice, in that portion of the **Northwest Kodiak and Southwest Kodiak districts** south of the latitude of **Cape Kuliuk, Chinook (king) salmon 28 inches or greater in length** may not be retained by purse seine gear in the commercial fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office. Recent salmon fishery information may be obtained by calling the Department's 24-hour record-a-phone at 486-4559.
