East Alsek River: will open from 12:01 p.m., Sunday, August 7, through 12:00 noon, Tuesday, August 9, 2022.

Alsek River: will be open from 12:01 p.m., Sunday, August 7, through 12:00 noon, Wednesday, August 10, 2022.

Yakutat Bay: will be open from 12:01 a.m., Sunday, August 7, through 12:00 noon, Wednesday, August 10, 2022.
