2023 KETCHIKAN HERRING FISHERY UPDATE #3

An aerial survey was conducted today, March 28, in the Revilla Channel and Craig areas.

Craig

Today's aerial survey covered the entire Craig area from Trocadero Bay to San Christoval Channel and Portillo Channel to Point Amargura. Weather conditions were good with clear skies, bright sun, northerly wind, and excellent visibility. No herring spawn was observed. Predators remain in the area and were less active than previously observed. Approximately 235 sea lions and 5 humpback whales were observed in the greater Craig area with the largest concentration near Fish Egg Island. There are approximately 45 pound structures on the grounds. No herring have been introduced into pounds.

Revilla Channel

Today's aerial survey covered Mary Island, and the Cat and Dog Islands area. Weather conditions were excellent with mostly sunny skies, a northerly wind, and excellent visibility. Approximately 1.2 nautical miles (nmi) of active spawn was observed on Double Island and a small spawn was beginning on the northern shore of Dog Island. Approximately 50 sea lions were in the immediate vicinity of Double Island with no other predator activity observed in state waters.
