## KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #03 For Emergency Order #4-FS-K-03-23

There will be a <u>72-hour extension</u> to the current commercial salmon fishing period from 9:00 p.m. Thursday, June 15 until 9:00 p.m. Sunday, June 18 in the following areas:

- The Central and North Cape Sections of the Northwest Kodiak District; and
- The Southwest Afognak Section of the Afognak District.

There will be an <u>81-hour</u> commercial salmon fishing period from **noon Thursday**, June 15 to 9:00 p.m. Sunday, June 18 in the Outer Karluk Section of the Southwest Kodiak District.

#### As previously announced:

The following areas are currently scheduled to close at 9:00 p.m. Thursday, June 15:

- The Cape Alitak, Humpy-Deadman, Alitak Bay, Moser Bay, and Olga Bay Sections of the Alitak District.

The following areas will <u>close</u> at **9:00 p.m. Thursday, June 15**:

- The Anton Larsen Bay, Sharatin Bay, Kizhuyak Bay, Terror Bay, Inner Uganik Bay, Spiridon Bay, Zachar Bay, and Uyak Bay Sections of the Northwest Kodiak District;
- The Northwest Afognak, Pauls Bay, and Perenosa Bay Sections of the Afognak District;
- The Eastside Kodiak District; and,
- The **Big River** and **Outer Kukak Bay Sections** of the **Mainland District**.

## Closed Water Adjustments:

Closed waters are reduced until 9:00 p.m. Thursday, June 15 in the following areas:

- At **Kaflia Creek** (stream #262-301) to the stream terminus;
- At **Saltery Creek** (stream # 259-415) to the stream terminus.

#### As previously announced:

The following areas will remain open until further notice:

- The Inner Kitoi Bay, Outer Kitoi Bay, Duck Bay, and Izhut Bay Sections of the Afognak District;
- The Foul Bay Special Harvest Area; and,
- The Waterfall Bay Special Harvest Area.

Fishermen are reminded that in the Kodiak Area (including the Mainland District) beginning at noon Friday, June 9, until further notice, Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the commercial fishery and must be returned to the water unharmed.

### **Closed Water Adjustments:**

Closed waters are **reduced** <u>until further notice</u> in the following locations:

- In **Foul Bay** to the stream terminus at Hidden Lake Creek (stream #251-406);
- In **Waterfall Bay** to the stream terminus at Little Waterfall Creek (stream #251-822) and to the stream terminus at Big Waterfall Creek (stream #251-821); and,
- In **Kitoi Bay** to the ADF&G markers located in Little Kitoi and Big Kitoi Bays (near stream #s 252-323 and 252-324).

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office.
