## Sand Point Commercial Salmon Fishery Advisory Announcement #06 For Emergency Order #4-FS-M-SP-02-23

During the February 2023 Board of Fisheries meeting, management action #1 was agreed upon which would reduce the second, third, and fourth fishing periods by 50% within the Shumagin Islands Section of the Southeastern District in order to achieve the lower bound of the Chignik River early run sockeye salmon escapement goal. To date, the lower bound of the sockeye salmon escapement goal is not being achieved and in turn need to reduce the commercial fishing period within the Shumagin Islands Section for seine gear. If the lower bound of the Chignik early run sockeye salmon escapement goal is projected to be met, restrictions in the Shumagin Islands Section will be lifted.

Commercial salmon fishing by <u>seine gear</u> will be allowed in the Shumagin Islands Section of the Southeastern District from <u>6:00 a.m. Friday, June 16 until 3:00 p.m. Saturday, June 17.</u>
