# Sand Point Commercial Salmon Fishery Advisory Announcement #10 For Emergency Order #4-FS-M-SP-06-23

During the February 2023 Board of Fisheries meeting, management action #1 was agreed upon which would reduce the second, third, and fourth fishing periods by 50% within the Shumagin Islands Section of the Southeastern District in order to achieve the lower bound of the Chignik River early run sockeye salmon escapement goal The lower bound of the Chignik River early sockeye salmon escapement objective of 146,000 fish has been achieved for June 25. The lower bound of the Chignik early run sockeye salmon escapement goal is projected to be met, therefore restrictions in the Shumagin Islands Section will be lifted.

Commercial salmon fishing by <u>seine gear</u> will be extended in the Shumagin Islands Section of the Southeastern District from <u>4:00 a.m. Tuesday</u>, <u>June 27 until 11:59 p.m. Wednesday</u>, <u>June 28.</u>

#### As previously announced:

The South Unimak and Shumagin Islands June fisheries will open to <u>drift gillnet and set gillnet gear</u> during the following times and dates:

From 6:00 a.m. Sunday June 25 until 10:00 p.m. Wednesday, June 28 in the following districts and sections:

#### Set gillnet and Drift gillnet:

Otter Cove and Cape Lutke Sections of the Unimak District (Sanak Island Section closed) Bechevin Bay Section of the Northwestern District Southwestern District

#### Set gillnet only:

West and East Pavlof Bay sections of the South Central District Shumagin Islands Section of the Southeastern District

The South Unimak and Shumagin Islands June fisheries will open to seine gear during the following times and dates:

From 8:00 a.m. Sunday, June 25 until 11:59 p.m. Wednesday, June 28 in the following districts and sections:

Otter Cove and Cape Lutke Sections of the Unimak District (Sanak Island Section closed)
Bechevin Bay Section of the Northwestern District
Southwestern District

As per 5 AAC 09.365 (e) all salmon caught **MUST BE RETAINED**, and must report the number of salmon caught, including those taken but not sold, on an ADF&G fish ticket. For the purpose of this subsection, "caught" means brought on board the vessel.

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
