Sand Point Commercial Salmon Fishery Advisory Announcement #13
For Emergency Order #4-FS-M-SP-10-23

Due to the results of the July 9 test fishery of 175.4 immature salmon per set, the Shumagin Islands Section of the Southeastern District **WILL NOT OPEN** to commercial salmon fishing by seine gear from 6:00 a.m. Monday, July 10 until 6:00 p.m. Tuesday, July 11, 2023. The next immature test fishery will be scheduled for July 12, 2023.

Commercial salmon fishing by **seine gear** will be allowed for 36 hours from 6:00 a.m. Monday, July 10 until 6:00 p.m. Tuesday, July 11 in the following districts and sections:

Unimak District
Southwestern District
South Central District

Commercial salmon fishing by **set gillnet** will be allowed for 36 hours from 6:00 a.m. Monday, July 10 until 6:00 p.m. Tuesday, July 11 in the following districts and sections:

Unimak District
Southwestern District
South Central District
Shumagin Islands Section of the Southeastern District

Commercial salmon fishing by **drift gillnet gear** will be allowed for 36 hours from 6:00 a.m. Monday, July 10 until 6:00 p.m. Tuesday, July 11 in the following districts and sections:

Unimak District
Ikatan Bay Section of the Southwestern District

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
