Sand Point Commercial Salmon Fishery Advisory Announcement #24 For Emergency Order #4-FS-M-SP-20-24

Commercial salmon fishing will be extended from 9:00 p.m. Tuesday, August 27 until further notice in the following districts and sections:

Morzhovoi Bay (284-60), Thin Point (284-75), General (stat areas 284-47 and 284-70), and the Deer Island Sections (284-55) of the Southwestern District;
South Central District; and
the Shumagin Islands Section of the Southeastern District.

Commercial salmon fishing will be extended for 96 hrs. from 9:00 p.m. Tuesday, August 27 until 9:00 p.m. Saturday, August 31 in the Beaver Bay, Balboa Bay, Southwest Stepovak, Northwest Stepovak, and East Stepovak Sections of the Southeastern District.

Additionally, **Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the Unimak, Southwestern, South Central, and Southeastern Districts of Area M** during a commercial salmon fishery and must be returned to the water unharmed.

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
