# Prince William Sound Salmon Fishery Announcement #71

**COPPER RIVER DISTRICT:** The Copper River District will open at 7:00 am on Monday, September 15 for a 24-hour commercial drift gillnet fishing period. The standard management strategy for coho salmon is one or two 24-hour periods per week depending on escapement and harvest levels.

The grass bank marker line is defined in 5 AAC 24.350(1)(A) with the exception of this year's extension of the closure line across Little Softuk (see **bold font below**). This closure line is defined with the following points:

Waters north of this line, within sloughs, and in Boswell Bay within the bay (5 AAC 24.350 (1)(A)) are closed to commercial and subsistence salmon fishing <u>during all periods</u>.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent in time and area with commercial fishing periods, unless otherwise stated, until the Copper River District is closed at the end of the season. Additionally, waters of the Copper River District will open to subsistence fishing from 6:00 am to 10:00 pm on all Saturdays from June 28 through October 25. Prince William Sound Management Area salmon subsistence permits may be obtained through any ADF&G office or online (https://www.adfg.alaska.gov/Store/). In Cordova, permits will be available during normal business hours Monday through Friday from 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m. To assist with inseason harvest tracking, permit holders are encouraged to call the Cordova office at 907-424-3212 or report online (https://www.adfg.alaska.gov/Harvest/) to provide preliminary harvest reports.

For the week ending September 6, the actual Copper River Delta survey count was 16,030 coho salmon versus an anticipated range of 21,447 – 44,904. High water and associated turbidity resulted in poor survey conditions in some index reaches. The Eyak Lake drainage, which historically represents approximately 22% of Copper River Delta coho salmon escapement indices, was largely unsurveyable. Preliminary harvest estimates from the 24-hour

period that started on Monday, September 8 are 44,300 coho salmon with 233 deliveries. Preliminary harvest estimates from the 24-hour period that started on Thursday, September 11 are not yet reported.

**BERING RIVER DISTRICT:** The Bering River District will open at 7:00 am on Monday, September 15 for a 24-hour commercial drift gillnet fishing period. The standard management strategy for coho salmon in the Bering River District is to fish concurrent fishing time with the Copper River District. For the week ending September 6, the actual Bering River District survey count was 3,590 coho salmon versus an anticipated range of 8,803 – 22,345. Preliminary harvest estimates from the 24-hour period that started on Monday, September 8, are 13,200 coho salmon with 54 deliveries. Preliminary harvest estimates from the 24-hour period that started on Thursday, September 11, are not yet reported.

<u>COGHILL DISTRICT:</u> The Coghill District, excluding the Esther Subdistrict and the WNH THA and SHA, will open to commercial drift gillnet harvest for a 36-hour fishing period starting at 8:00 a.m. on Monday, September 15. PWSAC recommends keeping the Esther Subdistrict closed to allow for coho brood collection. Preliminary harvest estimates from the 36-hour period that started on Monday, September 8, were 8,450 coho salmon with 42 deliveries reported.

**SEINE FISHERIES:** The 2025 PWS purse seine season will close at 8:00 pm tonight, September 12. Any permit holders interested in additional fishing opportunities should contact ADF&G in Cordova. Preliminary commercial common property pink salmon harvest estimates for the 2025 PWS season are 36.21 million pink salmon, composed of 23.70 million SGH, 6.97 million wild, and 5.54 million PWSAC pink salmon.

The next scheduled fisheries announcement is anticipated at 2:00 pm Wednesday, September 17.
